# TOWN OF TREMONT SELECTMEN'S WORKSHOP WITH MDOT TREMONT TOWN OFFICE MEETING ROOM MONDAY, MARCH 24, 2008 5:00 PM

1. Board met with MDOT representatives to discuss state route 102 route numbering, State Highway designation and reconstruction

In attendance were Chairman Scott Grierson, Selectmen Heath Higgins, Chris Eaton, Lester Closson, Town Manager Millard Billings, Recording Secretary Heidi Farley, MDOT representatives Terry Hannum and Pete Coughlan, former Selectman Charlie Dillon, Mount Desert Islander reporter Mark Good and Bar Harbor Times reporter Laurie Schrieber. Selectman Kathi Thurston arrived at 5:22 pm.

Chairman Scott Grierson called the workshop to order at 5:01 pm.

Concerning the path of the major collector leading to the Ferry MDOT Representative Pete Coughlan has concerns about making sure the residents are notified and are okay with the switch. MDOT Representative Terry Hannum said he doesn't think the State will trade a three rod road for a two rod road but he will check.

Chairman Scott Grierson told MDOT representatives that the Town is doing its part by raising \$75,000.00 every year towards getting our roads fixed and we see no movement from the State. "It is very frustrating" Chairman Grierson said. MDOT Representative Terry Hannum said he hears our frustration and not to loose heart. Tremont is currently number 2 out of 8, but funding has fallen short.

MDOT Representative Pete Coughlin told the Selectmen that the one mile stretch between the gas station and Bernard corner is a State Highway not a major collector. It is a minor collector and needs to be classified as one because that is the way it functions. It will be put in decent shape before given over to the Town. The Town will be responsible for plowing and sanding and the State will still be responsible for usual maintenance.

MDOT Representative Pete Coughlin told the Selectmen that it doesn't make sense to continue route 102 past the gas station because that is what road names are for and it is road numbering protocol to not split a route at an intersection.

MDOT Representative Pete Coughlin told the Selectmen that contacting their representatives is the best way to get some sort of attention to the road problems.

# A. PROPOSED BOUNDARY LINE AGREEMENT

Surveyor Thomas Benson explained to the Selectmen that he doesn't feel he has enough evidence to justify where the boundary line is between the Town and Resident John Buckwalter. Mr. Benson said he would like to make this work for the Town as well as Mr. Buckwalter

Selectman Heath Higgins said "you need to put aside the addition and structure, this is not a swap, and the Town needs to have a line. The line needs to be determined and finalized or it could be to the Towns disadvantage next time. We need to pick a line and make a decision."

Chairman Scott Grierson stated that the Town needs its own survey of Town properties as soon as possible, if this is not beneficial to the Town he would lean against it, and Mr. Buckwalter could do a citizens petition if the Board goes against what he is asking for.

Selectman Heath Higgins said the Town is Town people and the Town should decide whether or not to make a line agreement with Mr. Buckwalter. The Town isn't loosing anything and it will clear up a problem.

Selectman Chris Eaton said that he does not see this as a swap, just a boundary line agreement.

**MOTION** by Selectman Kathi Thurston to get survey done of Town lot ASAP, seconded by Selectman Lester Closson. Motion passed 5-0.

# 8. TOWN MANAGER'S REPORT

#### A. MUNICIPAL APPROPRIATIONS

Town Manager Millard Billings reported that last year the Town sent out bids for backup snowplow driver and truck and that John Goodwin Jr. was the lowest bidder. Last year the Board authorized him to go to the State surplus auction and buy one truck not three so that is why we needed backup.

The Selectmen authorized Town Manager Millard Billings to go to auction this Thursday and purchase one or two trucks if reasonable.

Town Manager Millard Billings reported that the salt/sand shed was 11,000.00 over budget because of blasting, ditch and site work but the Town can use some of the surplus from Public Works to cover it.

Selectmen agree that they would like to talk to ADD next week and would like Town Manager Millard Billings to have MMA look over the warrant article for next week.

Town Manager Millard Billings presented an optional and a proposed budget for the administration (see attached).

**MOTION** by Selectman Chris Eaton to approve optional budget which includes \$45,000.00 for a full time CEO /Assessor, seconded by Selectman Heath Higgins. Motion passed 4-1. Selectman Kathi Thurston opposed because she is not sure that a new full time employee is needed.
