# PUBLIC HEARING TREMONT BOARD OF SELECTMEN TREMONT TOWN OFFICE MEETING ROOM MONDAY, MAY 19, 2008 6:00 PM

THE TREMONT SELECT BOARD HELD A PUBLIC HEARING FOR THE CONSIDERATION OF APPLICATIONS FOR THE FOLLOWING:

Chairman Scott Grierson opened the Public Hearing at 6:00 pm. Town Manager Millard Billings reported to the Selectmen that a packet was submitted this afternoon from Steve and Kellie Carter about concerns they have and copies of State Law pertaining to the sale of liquor (see attached). Town Manager Millard Billings also showed the Selectmen one report from the Sheriff's Department (see attached) but was unable to obtain reports from other agencies. Robert Cousins, owner of Cap'n Nemo's said "I run a tight ship, if someone drinks too much I take them home. We have never had an OUI." After much discussion Chairman Scott Grierson asked if anyone had any closing words. Neighbor Kellie Reed-Carter suggested keeping amendments to Special Amusement Permit as approved last year and for later patrols of the Police. Town Manager Millard Billings asked where the Subsurface Waste water goes. Robert Cousins said that several different people pump it and they will get the receipts. Selectman Lester Closson said that he hadn't seen a truck there in over a year and that the former owner had his own truck to pump it and would provide the Town with a manifest.
