2. ROLL CALL

5. APPROVAL OF WARRANTS

Motion made by Selectman Scott Grierson, with second by Selectman Kathi Thurston, to approve Warrants 36 - 40. Motion passed 5 - 0.

6. NEW BUSINESS

A. SCHOOL REFERENDUM WARRANT & MDIHS FUNDING FORMULA

1. Warrant for the Special town Meeting on the School Referendum November 4, 2008 needs to be approved and signed (see attached).

Motion made by Selectman Scott Grierson, with second by Selectman Kathi Thurston, to call a Special Town Meeting Referendum on November 4, 2008 with the two Warrant Articles that have been provided. Motion passed 5 - 0.

2. HIGH SCHOOL FUNDING FORMULA

The Reorganization Planning Committee chose not to change the funding formula as part of the Alternate Organizational Structure reorganization plan, but would like MDI residents to consider discussion it at an island wide forum to be held shortly after the AOS ratification vote. League of Towns is considering sponsoring a forum on December 4th.

The Town of Mount Desert is not happy with MDI's High School formula (33% enrollment, and 67% valuation) and would like to discuss changing the formula. They pay around \$20,000 per student, which is more then the other towns in the AOS, and they want to discuss changing the formula.

Superintendent Rob Lebow explained that Trenton and Swans Island students pay \$9,000 because the tuition amount is set by the State.

The Selectmen felt they should attend the meeting.

B. ACTION GENERAL ASSISTANCE MAXIMUMS & APPENDIXES

Each year the Department of Human Services sends the Town General Assistance Maximums and Appendixes that need to be adopted by the Town (see attached). **Motion** made by Selectman Scott Grierson, with second by Selectman Kathi Thurston, [the Selectmen] approve the General Assistance Maximums and Appendixes as provided to [them] by Maine Municipal Association. Motion passed 5 - 0.

C. AWARD ROAD SAND BID

The Town sent out Bid Proposal Forms for 2,000 cubic yards of ½ inch minus sand, to be delivered in 1,000 cubic yard increments as requested between December 1, 2008 and April 30, 2009, mixed with salt, and stockpiled in the salt/sand shed (see attached).

John Goodwin Jr. \$17,960.00 Doug Gott and Sons Inc. \$22,617.00

Motion made by Selectman Scott Grierson, with second by Selectman Chris Eaton, to go with the lowest bidder, John Goodwin Jr., for \$17,960 per 2,000 cubic yards. Motion passed 5 - 0.

D. ADD REPORT CONTRACT WITH EMR

Town Manager Millard Billings suggested the Selectmen table this item to give them time to read the contract and a representative of ADD to be present to answer any questions they may have. (Contract draft attached)

Motion made by Selectman Scott Grierson, with second by Selectman Kathi
Thurston, to table the contract with EMR until the next meeting. Motion passed 5 - 0.

E. SEARCH FOR ASSESSOR/CEO

New search for an Assessor/Code Enforcement Officer will end November 1st. The Selectmen chose to interview qualified candidates only and to screen the applicants next meeting as well as work up a list of questions. They will also set up the interviews on nights they do not have meetings.

F. DOWNEAST RC&D BIOMASS FOR PUBLIC INSTITUTIONS

Downeast RC&D will host an informational presentation on the possibilities of the conversion of Community Facilities from oil to biomass heat (see attached) on November 7, 2008 at the University of Maine at Machias Clipper Lounge 9 am to 12 noon.

The Selectmen chose to wait and see what other municipalities did.

G. RESIGNATIONS

Motion made by Selectman Scott Grierson, with second by Selectman Chris Eaton, to accept Stewart Murphy's resignation as Harbor Master. Motion passed 5 - 0.

Motion made by Selectman Scott Grierson, with second by Chairman Charlie Dillon, to appoint David Schlaefer as interim Harbor Master to work with the Town Manager and staff. Motion passed 5 - 0. The Selectmen suggested Vice Chairman Mel Atherton could act as Chairman of the Harbor Committee. **Motion** made by Selectman Scott Grierson, with second by Selectman Chris Eaton, the Selectmen request the Harbor Committee begin its search for a new Harbor Master. Motion passed 5 - 0.

H. APPOINTMENTS

Michele Marks, Chairman of the Bass Harbor Library Board of Trustees, has recommended appointing Chris Richardson to the Bass Harbor Library Board of Trustees (see attached).

Motion made by Selectman Scott Grierson, with second by Selectman Chris Eaton, to appoint Chris Richardson to the Library's Board of Trustees for the remainder of Linda Lord's term. Motion passed 5 - 0.
