1. CALL TO ORDER

Chairman Charlie Dillon called the May 24, 2010 meeting to order at 6:05 pm.

2. ROLL CALL

Present were Chairman Charlie Dillon, Selectmen Lester Closson, Chris Eaton, Bobby Lee and Kathi Thurston, Town Manager Millard Billings, and Recording Secretary Debbi Nickerson.

Members of the public present were Mark Good – Islander, Frank Gray, Sr. – Tremont Cemetery Committee.

3. ADJUSTMENTS/ADOPTION OF AGENDA

4. ELECTION OF OFFICERS

A. CHAIRMAN OF THE BOARD OF SELECTMEN

The Selectmen voted by secrete ballot for Chairman. Town Manager Millard Billings tallied the votes, three for Kathi Thurston and two for Charlie Dillon. Selectman Kathi Thurston declined. Chairman Charlie Dillon accepted the appointment.

B. VICE CHAIRMAN OF THE BOARD OF SELECTMEN

The Selectmen voted by secrete ballot for Vice Chairman. Town Manager Millard Billings tallied the votes, four for Kathi Thurston and one for Bobby Lee. Selectman Kathi Thurston accepted the appointment.

8. OTHER

Frank Gray Sr., Tremont Cemetery Committee, spoke on the rehabilitation of the Benji - Gott Cemetery, off Tremont Road in Seal Cove, where trees and stumps have been removed, gravestones repaired and the Town's Public Works crew is filling in sunken graves. He also encouraged the Select Board to begin the process to take possession of the Kelley Cemetery, on the Seal Cove Road. It is surrounded by Acadia National Park and Mr. Gray is not sure who the owner is. The Selectmen agreed and asked Town Manager Millard Billings to begin the proceedings for the Kelley Cemetery and the Fry Cemetery.

9. AGENDA ITEM 8. NEW BUSINESS

A. REVIEW BIDS FOR PORTABLE TOILETS

Bids closed on May 19th at 4:00 pm. At 4:01 pm bids were opened and were publicly read aloud, the bids were as follows (see attached):

Additional bi-weekly if needed 35.00

Chad Terry (G T Outhouses) 18.25 weekly

Additional bi-weekly if needed 25.00

The Selectmen asked Town Manager Millard Billings to include the donation of a portable toilet for the Backside Blast in next year's contract.

Motion made by Selectman Chris Eaton, with second by Selectman Lester Closson, to award the portable toilet bid to G T Outhouses. Motion passed 4-1, Selectman Bobby Lee voted against.

B. ACTION ON OUTSTANDING PROPERTY TAX LIENS

Per Town Meeting vote prior owners could have the opportunity to redeem the property if all taxes, interest, penalties and costs then due, plus all costs of the sale are paid in full prior to such sale.

There are currently four parcels of property that have outstanding 2008 tax liens. Two of the four have made prior payment arrangements that the Board agreed to honor. Neither of the Individuals has lived up to their payment arrangements.

- One owes a balance of \$105.60 on the 2008 taxes. The last payment received was December 4, 2009.
- The other owes a balance of \$1,905.42 on the 2008 taxes. The last payment received was February 12, 2010. This person is trying to get the bank to refinance and pay property taxes and establish an escrow account for future taxes. The bank is supposed to send a letter of acknowledgement.

Of the remaining two:

- One has paid \$200.00 of April 28, 2010 and \$200.00 on May 5, 2010 and currently owes \$724.86 on the 2008 taxes, \$1,067.65 on the 2009 taxes and \$932.26 on the 2010 taxes. The 2011 taxes will be due at the end of July.
- The other one has not responded. Town Manager Millard Billings has mailed letters to four different addresses that we could find from prior deeds and on the internet.

The Selectmen asked if the trailer was included for the property owner that has not responded. Town Manager Millard Billings assured them it is. The Selectmen agreed to set the auction date for July 12, 2010 at their regularly scheduled meeting.

C. ACTION CONCERNING 2001 LIEN AND 2007 TAX

The Auditors have discovered a 2001 Tax Lien, and a Real Estate Tax from 2007 that are still on the books.

• The 2001 Tax Lien is for a Tree Growth Penalty Supplemental from 2001. McKenzie remembers Diane finishing work on this during the week when they worked together when McKenzie was first hired. She seems certain it was paid, but it is showing in the computer as unpaid. Town Manager

• The 2007 Real Estate Tax happened on August 10, 2006. The Real Estate Tax of \$3,720, 258.52 was committed. Then the Personnel Property Tax of \$7,161.35 was committed. These two numbers account for the total tax of \$3,727,419.87 that was the Commitment of 2007. On that same day \$3,384.36 was committed to the computer, no one knows why. Town Manager Millard Billings recommends following the auditor's advice and writing off the \$3,384.36 as uncollectible.

Town Manager Millard Billings asked the Selectmen to table the 2001 Tax Lien to give the staff more time for research. The Selectmen agreed.

11. AGENDA ITEM 10. TOWN MANAGER'S REPORT

A. A time and date needs to be set to award the Boston Post Cane to the oldest citizen. Ellwood Banfill has been selected as the oldest citizen. The Selectmen decided to present the cane to Mr. Banfill on June 7, 2010 at 5:00 pm.

- B. The loam pile on DOT lot has been screened and some is being used to level sunken grave sites at the Benji Gott Cemetery.
- C. Vandalism on the Town Office Building have been resided. Still no report of leads.
- D. Memo and Request to Chairs of All Town Committees from the Comprehensive Plan Committee (see attached).
- E. The Town Meeting Warrant was missing three Articles that had been approved by the Board for action. Selectman Bobby Lee asked about warnings being issued or not issued at the dock to boats being tied up for more then two hours. Town Manager Millard Billings said that if your boat is broken down and your boat will be tied up for more then the allowed two hours you can inform Harbormaster David Schlaefer.

Selectman Bobby Lee has received complaints about the Harbormaster boat being tied up at the dock. Town Manager Millard Billings explained he feels that the Harbormaster is our Town's harbor enforcement and is allowed to be tied up at the dock readily available. Chairman Charlie Dillon said a Harbor Committee Member complained to him about the Harbormaster boat, but Mr. Dillon told him the Select Board does not want to micro manage the harbor and besides, it's the Harbor Committees purview. Chairman Charlie Dillon asked Town Manager Millard Billings to bring up the Harbormaster's boat and the chain on the Town's mooring to the Harbor Committee.

Selectman Bobby Lee asked if the Town would be selling any floats this year. Town Manager Millard Billings said he felt only finger floats might be available for sale after the dredge project.
