4. APPROVAL OF MINUTES

A. MINUTES OF JANUARY 24, 2011

Motion made by Selectman Kathi Thurston, with second by Selectman Lester Closson, to approve the minutes of January 24, 2011. Motion passed 4 - 0.

6. NEW BUSINESS

A. RECYCLING PROGRESS REPORT

The Selectmen received several e-mails between Tony Smith and Town Manager Millard Billings (see attached) and a complaint about the recycling changes (see

attached). The Selectmen discussed how to make the recycling easier for the Town's residents and decided to move both locations to the Town Office back parking lot. The dumpsters will be recorded on the security cameras as well as the Town staff can keep an eye on them. That should alleviate at least some of the trash problems and the Public Works crew will be better able to keep the dumpsters plowed, so access will be improved. The Board of Selectmen chose to make this move by April 1, 2011.

B. MUNICIPAL REVIEW COMMITTEE GUARANTEED ANNUAL TONNAGE MRC has sent out a memo about pending penalties resulting from 2010 MSW deliveries below GAT (see attached). The Board of Selectmen agreed, the GAT must be lowered for next year.

Motion made by Selectman Lester Closson, with second by Chairman Charlie Dillon, to approve the budget request of \$134,000 for Winter Roads. Motion failed 2-2. Selectmen Bobby Lee and Kathi Thurston voted against.

Motion made by Selectman Lester Closson, with second by Chairman Charlie Dillon, to reconsider the previous motion (for Winter Roads). Motion passed 4-0.

Motion made by Selectman Lester Closson, with second by Chairman Charlie Dillon, to approve the budget request of \$134,000 for Winter Roads. Motion passed 3-1. Selectman Kathi Thurston voted against.

8. TOWN EQUIPMENT (see attached)

Motion made by Selectman Lester Closson, with second by Selectman Bobby Lee, to approve the budget request of \$14,000 for Town Equipment. Motion passed 4-0.

9. STREET LIGHTS (see attached)

Motion made by Selectman Lester Closson, with second by Selectman Bobby Lee, to approve the budget request of \$12,800. Motion passed 4 - 0.

On March 30th at the Somesville Fire Station at 5:30 pm the League of Towns will be sponsoring a Collaboration Meeting between the member Towns. This is a continuation of the previous meeting. All Selectmen and Town Managers are invited.

Keith Higgins, Tremont Volunteer Fire Department, explained that some of the money the Department is asking for is to make improvements to the Seal Cove parking lot. He also invited the Selectmen to attend their monthly meetings on the first Wednesday of the month. According to Mr. Higgins the Fire Department's Bylaws state that there need to be 3 Selectmen on their Board. The Selectmen said they did not like the idea of 3 sitting Selectmen attending their meetings because that would have to be treated as a Selectmen's Meeting which would involve posting as a Selectmen's Meeting. It was suggested the Fire Department should update their Bylaws.

Motion failed 2-2. Chairman Charlie Dillon and Selectman Lester Closson voted against.

Motion made by Selectman Kathi Thurston, with second by Selectman Bobby Lee, to reconsider the previous motion. Motion passed 4-0.

Motion made by Selectman Kathi Thurston, with second by Selectman Bobby Lee, to go into executive session pursuant to Title 1 Maine Revised Statutes annotated Section 405 Subsection 6 Paragraph C to discuss the acquisition or disposition of real property or interest therein because premature disclosure of the information would prejudice the bargaining position of the Selectperson. Motion passed 4-0. At 7:45 pm the Selectmen went into executive session.

Motion made by Selectman Lester Closson, with second by Selectman Bobby Lee, to come out of executive session. Motion passed 4-0. The Selectmen came out of executive session at 8:15 pm.

The Selectmen have decided to make a final offer for the Hinton estate to Acadia Wildlife Foundation of \$275,000. Town Manager Millard Billings is authorized to write Anne Rivers a letter stating the Board of Selectmen's final offer of \$275,000 and have her answer by March 15, 2011 or the Selectmen will withdraw their offer.

14. POSSIBLE EXECUTIVE SESSION ACQUISITION OF LAND

Town Manager Millard Billings received a letter from the Attorney representing the Fudges (see previously attached letter). The Trustee is trying to sell the property through an agent before putting it out to auction. It has been listed at \$65,000. The Town has received first refusal. The Select Board authorized Town Manager Millard Billings to offer \$20,000 for the .69 of an acre lot.
