E. AOS #91 & ANP DISCUSS SCHOOL CLOSING

The question arose during school consolidation discussions as to what would happen to the Tremont School if the facility were closed. The deed (see attached) for the school property clearly states "...this conveyance is made upon the expressed condition that all of the land hereby conveyed shall be used exclusively and perpetually for school purposes, and that upon the discontinuance of such use of said land, or any part thereof, all of the land conveyed hereunder shall revert to the United States of America..."

The Town's position has been that as long as any kind of school (boatbuilding, sailing, adult education or private school, charter school, pre-school) was used at the school building it would satisfy the intent of the deed.

The park Superintendent Sheridan Steele, in correspondence with Rob Liebow (see attached) says that if the building was not run by the school district it would revert to the park.

MOTION by Selectman Jim LaPrade for the Town to retain an attorney to provide opinion on what the deed is telling us, seconded by Selectman Hugh Gilley. Motion passed 5-0.

F. FUNDING THROUGH TAXATION FOR RCC SERVICES

Town Manager Millard Billings reported that the Chairman of the Board of Selectmen of Southwest Harbor sent a letter (see attached) regarding a newspaper article (see attached) in which the Hancock County Commissioners are quoted as saying they propose to fund the RCC budget through taxation in 2012.

Town Manager Millard Billings drafted a letter (see attached) in support of the Southwest Harbor position regarding forcing Towns to pay for services that they do not use.

MOTION by Selectman Hugh Gilley to approve letter to RCC, seconded by Selectman Jim LaPrade. Motion passed 5-0.
