## 6. NEW BUSINESS:

A. Amended DRAFT Tremont Harbor Management Ordinance: No action taken as the Harbor Committee did not vote to forward this item to the Board.

## **B.** Amended DRAFT Tremont Wharf & Facilities Ordinance:

The Harbor Committee voted to request the Board place this item on the Town Meeting Warrant. Robert Lee asked about probable change to the 75% resident 25% non resident caps and would this change as individuals were removed from the list?

Greg Dow related that permits end and if the person is not eligible they would not qualify for a new permit and that the count was made to determine the % the Harbor Committee was questioned as to how to calculate the %. The new changes should prevent future problems with residencies.

Dean Wass indicated that historically there were always more than 25% and no more permits issued until the ration is right and that the ordinance change was to correct the residency requirements. It was not very specific.

The Town Manager clarified that the Harbor Committee was questioned as to how the Harbor Master should

count those on the list to determine the 75% – 25% and that the current Wharf ordinance defines a Resident Vessel as one whose excise tax is paid in Tremont and does not specify that the person live in Tremont. He commended the Harbor Committee for their work on the Ordinance to clear this up. Robert Lee spoke to the importance of combining (survey) the lots at the Bernard Wharf. Hugh Gilley asked what the Ordinance says now regarding residency? Chris Eaton spoke to the fact that we cant pull Dean Wass indicated the proposed changes now require that a 12 month residency is needed. Motion by James LaPrade, to include the Amended Wharf & Facilities Ordinance on the Town Meeting Warrant, second by Robert Lee. **Vote 5 Yes 0 No**

The Town Manager indicated that the Town Report will be going to the printers on the 8<sup>th</sup> of April. The Town Clerks recommendations for dedication of the Town Report were reviewed. The Board considered all on the list worthy. The concusses was #4.

#### B. FY-2015 DRAFT Municipal Budget:

Christopher Eaton indicated that the Board has had time to review the proposed budget. The Town Manager indicated the total proposed budget would be \$1,720,169.20. Dean Wass asked about the previously reported \$27,000 discrepancy and the \$10,000 typo in the budget computer entry of last year's budget.

The Town Manager explained that in two areas the 2013 Town Meeting Warrant did not agree with the budget entries and the Warrant was the correct amount. A \$27,000 budget adjustment has been made. The \$10,000 typo in ACO Training has not been corrected. Carl indicated that this short-fall should be able to be off-set by the DEP reimbursements and belt tightening.

Kathi Thurston asked when the Warrant Article funding would be determined? the Board determined that would be this evening.
