- **D. Wharf Garage Lease:** *Request of the Town Manager to renew the lease with D&R Bait.*

E. Wharf House Lease: *Request of the Town Manager to renew the lease with Leeman Hodgdon.*

A motion was made by Chris Eaton and seconded by Stewart Murphy to renew the lease as it is written for one year. The motion passed unanimously.
