The Board accepted the meeting minutes from 1/30/13 with a change to line 23 incorrect date was entered. Feb. 6<sup>th</sup> should have been Feb. 9th.

Met with Attorney Cove regarding Central Mass Beagle club land located @ 0 Glenveiw St. map 026-015, Attorney Cove filed a real estate abatement application and feels the land should valued at \$50,000 and the building should be valued at \$40,000. The land had been removed from chapter 61B and placed into 61 which increased the value. Chairman Mardsen asked why he changed the chapter as we had worked with them in the past to try and get the best value possible and by changing to Forestry with a forester telling us 1.15 Ac was exempt that the value of the land was correct and no abatement could be issued for the land but the Board would look at the building. Attorney Cove felt that Chairman Marsden was biased and had made a decision before the meeting. Chairman Marsden then recused himself from working with the abatement as he didn't want Attorney Cove to feel that his application was not given the proper review. Assessor Fowler said he would make an appointment for a site visit but was not sure if the building value would change. After Attorney Cove left Assessors Fowler and Ambrosino agreed that the site visit would be conducted with Northeast Revaluation so there could be no question remaining. The Assistant will contact Northeast Revaluation to schedule the appointment for the site visit.

The Board approved 1 real estate abatement application and denied 1. Three real estate abatement certificates where signed and 1 personal property. 3 applications will need site visits scheduled within the next couple weeks
