The time being after 9:00 a.m. and the meeting duly posted with a quorum present, the meeting was called to order.

Informal Discussion (cont'd), Aggregation of Flows and Nitrogen Loading Throwbridge Acres a Conservation Design Development, 435 Sutton Street. Mike Weaver, Guerriere & Halnon, was present for the proponent.
