

RE:

Feasibility Study Borrowing

The Town held a sale today for Bond Anticipation Notes (BANs) to pay for the costs incurred for Feasibility Study. The sale was for BANs totaling \$465,000, dated June 18, 2010, and due on June 17, 2011.

As you know, the Town has been paying for the Feasibility Study throughout this fiscal year. MGL allows cities and Towns to inter-fund borrow, as long the amount borrowed is less than the balance in the Stabilization account. However, these internally borrowed funds must be externalized, either temporarily or permanently, before the end of the fiscal year.

There were four bidders:

Bidder	Principal	Coupon Rate	Net Interest
Unibank	\$465,000	1.15%	\$5,332.65
Eastern Bank	\$465,000	1.20%	\$5,564.50
Bank of Western Mass	\$465,000	1.20%	\$5,564.50
TD Bank	\$465,000	1.69%	\$7,836.67

Unibank won the bid with a 1.15% bid. The Town will pay a total of \$5,332.65 to borrow the funds for a full year. This expense will be funded through next year's debt budget without any added expense to the taxpayer.

We are working with the SBA to get the logins set up in order to apply for reimbursement for the study. We anticipate that they will be in place by the end of the month. Reimbursement requests will be submitted shortly thereafter.

The Board of Selectmen must approve any borrowing. The language for the motion is listed below:

Move that the Board of Selectmen award the bid for short term debt, totaling \$465,000, for the High School Feasibility Study, as authorized by Article 15 at the November 18, 2008 Fall Annual Town Meeting, for one year BANS dated June 18, 2010, and due June 17, 2011, to Unibank, at the net interest cost of 1.15%
