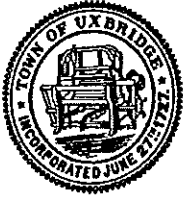

**BOARD OF SELECTMEN'S MEETING MINUTES**  
**BOARD OF SELECTMEN'S MEETING ROOM**  
**MONDAY, DECEMBER 12, 2011 – 7:00PM**

Present: Chair Bruce Desilets, Vice Chair Beth A. Pitman, Clerk Peter A. Petrillo and Selectman Jay Cahill. Also present, Town Manager Sean Hendricks. Absent: Selectman Cari Kay Robertson.

**I. CALL TO ORDER (not to exceed 20 minutes)**

- A. Announcements – There was a moment of silence in memory of Ernie Picard, former Veteran Agent for the Town of Uxbridge.
- B. Citizen's Forum – Mr. Richard Hurteau, Millville resident, complained about nuisance barking at 12 Quaker Street, Uxbridge. The Town Manager will follow-up and contact the residents. Mr. Peter Baghdasarian commented on the Zoning Bylaws.

**II. DOG HEARING – Discussion/Action/Vote**

- A. Dog Hearing – nuisance barking - 127 Douglas Pike – The Board passed over.

11/28/11 Meeting Minutes – **MOTION: I, Mr. Petrillo, move that the Board approve the 11/28/11 Meeting Minutes. Seconded by Mr. Cahill, the motion carried unanimously.**

- A. New High School Project/SBC Meeting Update – The Board passed over.
- B. Town Manager goals – A subcommittee was formed with Mr. Cahill and the Town Manager. The Board will continue discussions at their meeting on 1/23/12.

**V. NEW BUSINESS - Discussion/Action/Vote**

- A. DPW updates – Mr. Benn Sherman, DPW Director was present and updated the Board on pending projects and on-going activities within the Department of Public Works.
- B. Cable Advisory Committee – update/discussion – non-profit organization – The Board passed over.
- C. Temporary borrowing – wellfield development – Mr. David Genereux, Finance Director was present and discussed the temporary borrowing. Following discussion, **MOTION: I Ms. Pitman, move that the Board of Selectmen authorize the sale of \$285,000 in Bond Anticipation Notes to People's United Bank for a net interest cost of .78%, to be delivered on December 15, 2011; Said notes to be due and payable on March 15, 2012. Seconded by Mr. Petrillo, the motion carried unanimously.**

- D. Sutton Street – 100 Acre lot – request lease extension – Following discussion, **MOTION: I, Mr. Cahill, move that the Board not renew the lease for the 100 acre lot on Sutton Street by and between the Town of Uxbridge and Wright’s Dairy Farm, Inc. Seconded by Mr. Desilets, the motion carried unanimously.**
- E. Notice from CMRPC - new rules allow remote participation – Following discussion, **MOTION: I, Mr. Cahill, move that the Board of Selectmen authorize the adoption of remote participation in public meetings as prescribed in 940 CMR 29.10 (Open Meetings/Remote Participation), with such authorization applying to all subsequent meetings of all public bodies in the Town of Uxbridge. Seconded by Ms. Pitman, the motion carried unanimously.**
- F. Board of Selectmen 2012 meeting schedule – **MOTION: I, Ms. Pitman, move that the Board approve the Board of Selectmen 2012 meeting schedule (attached to the minutes). Seconded by Mr. Petrillo, the motion carried unanimously.**
- G. 2012 License Renewals – Common Victualler, Taxi, Class II and III, Auto Amusement Device, Alcohol and Entertainment – **MOTION: I, Ms. Pitman, move that the Board approve the 2012 License Renewals for Common Victualler, Taxi, Class II and Class III, Auto Amusement Device, Alcohol and Entertainment on the spreadsheet dated 12/12/11 (attached to the minutes). Seconded by Mr. Cahill, the motion carried unanimously.**




