- A. New High School Project Budget Transfers/Commitments/Contract Amendments –

Following discussion, MOTION: I, Ms. Pitman, move that the Board approve the Budget Transfer from Classification Code 0507-0000 Construction Contingency to Classification Code 0508-0000 Change Orders in the amount of \$102,122 required to fund change order #5. Seconded by Mr. Petrillo, the motion carried unanimously.

MOTION: I, Ms. Pitman, move that the Board approve the Shawmut Commitment Pay Code 0508-0000 Category Change Orders in the amount of \$102,122. Seconded by Mr. Petrillo, the motion carried unanimously.

MOTION: I, Ms. Pitman, move that the Board authorize the Chair to sign the Construction Contract for Construction Manager at Risk Services Amendment No. 7. Seconded by Mr. Cahill, the motion carried unanimously.

MOTION: I, Ms. Pitman, move that the Board approve and authorize the Chair to sign the Project Funding Agreement Budget Revision Request #8. Seconded by Mr. Petrillo, the motion carried unanimously.

The SBC Members updated the Board as to the status of the project. It is anticipated to be completed by the end of July. The SBC requested input from the Board as to the next steps on how to proceed. It is questionable if there will be extra money in construction contingency for any field work. Following discussion, the Board and SBC agreed to the following charge/action for the SBC:

- 1. Research safe environment
- 2. Prepare scope/cost estimates to complete the north field

3. Prepare scope/cost estimates to complete the south field/multi-purpose field and track

The Board will continue discussions at a joint meeting with the School Building Committee and School Committee on Wednesday 3/7/12 at the Uxbridge High School Library at 6PM. The Board will also consider a warrant article for town meeting and ballot vote.
