Present: Chair Bruce Desilets, Vice Chair Beth A. Pitman, Clerk Peter A. Petrillo, Selectman Cari Kay Robertson and Selectman Jay Cahill. Also present, Town Manager Sean Hendricks and Administrative Assistant Tracey Ante.

**I. CALL TO ORDER**

**A. Announcements**

The Town Election is Tuesday, May 22<sup>nd</sup>. All are encouraged to get out and vote.

Application – Alcohol - Alteration of Premises – Meadow View Tavern (Blissful Meadows Golf Course), 801 Chockalog Road

The Chair opened the public hearing. Mr. Gordon Bliss was present and discussed the application. Following discussion, the Chair closed the public hearing.

**MOTION: I, Mr. Petrillo, move that the Board approve the application for an Alteration of Premise for Meadow View Tavern Blissful Meadows Golf Course, 801 Chockalog Road. Seconded by Ms. Pitman, the motion carried unanimously.**

A. New High School Project/SBC Meeting Update – Mr. Desilets updated the Board.

**V. NEW BUSINESS - Discussion/Action/Vote**

A. Community Gardens – The Town Manager provided some background as to the formation of the Community Gardens. He mentioned that there was one article on the Spring Annual Town Meeting Warrant to develop a revolving account. This was passed over. The Charter speaks to the creation of town agencies. This requires town meeting vote. Therefore two articles would need to be submitted. He anticipates submitting the articles for the fall. Ms. Barbara Hall, Chair of the Uxbridge Community Gardens was present and discussed the program.

B. Warsaw Street – request for winter maintenance services – Mr. Mark Anderson with Heritage Design Group was present on behalf of the residents and discussed the proposed agreement. Following discussion, **MOTION: I, Mr. Cahill, move that the Town provide winter maintenance services for Warsaw Street from Oak Street to the beginning of the cul-de-sac. The Trustees are the responsible party for routine maintenance on this way. Seconded by Ms. Pitman, the motion carried unanimously.** Mr. Anderson was informed that there is no cash bond or active policy for the road. The policy was cancelled in March 2001.

C. Planning Board Fee Schedule revision (ANR) – Mr. Joe Leonardo, Planning Board Vice Chair was present and discussed the revised fee. **MOTION: I, Mr. Cahill, move that the Board approve the Planning Board fee schedule for ANR plans (81P). Seconded by Ms. Robertson, the motion carried unanimously.**

D. Athletic fields - Master Plan Committee – Following discussion, Mr. Cahill will contact the appropriate parties.

E. Application – Common Victualler License – Dynast Café, S. Main St. – **MOTION: I, Mr. Cahill, move that the Board approve the Common Victualler License application for Dynasty Café. Seconded by Ms. Robertson, the motion carried unanimously.**

F. Application – One Day Beer & Wine License – Uxbridge Rod & Gun Club, West St., Chicken BBQ, Sat. 6/16/12 – 4:00pm – 8:00pm – **MOTION: I, Ms. Pitman, move that the Board approve the One Day Beer & Wine License application for the Uxbridge Rod & Gun club for Saturday, 6/16 from 4:00pm – 8:00pm. Seconded by Mr. Petrillo, the motion carried 3-0-2 (Ms. Robertson and Mr. Cahill abstained).**

- G. Application – Common Victualler License – Uxbridge House of Pizza, S. Main St.- **MOTION: I, Mr. Cahill, move that the Board approve the Common Victualler License application for Uxbridge House of Pizza. Seconded by Mr. Petrillo, the motion carried unanimously.**
- H. DPW Union Contracts – endorse – **MOTION: I, Ms. Pitman, move that the Board endorse the DPW Union Contract for the period 7/1/2011 – 6/30/2014. Seconded by Mr. Cahill, the motion carried unanimously.**
- I. Street Light Restoration Request – Corner of Rt. 122 and Blackstone Street – **MOTION: I, Mr. Cahill, move that the Board deny the Street Light Restoration Request for the Corner of Rt. 122 and Blackstone Street. Seconded by Ms. Robertson, the motion carried unanimously.**

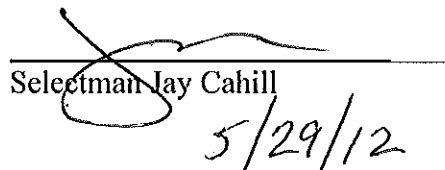
