- 2. Destination Imagination Whitin Team Team Managers Ms. Mary Anderson, Ms. Kris Holt and Mr. Brian Prince and the Destination Imagination Team were present. The team

presented their project. The team competed at the regional DI tournament on March 22<sup>nd</sup> and again at the state tournament at WPI on March 29<sup>th</sup>. At the state tournament the team was chosen to advance to the Global Finals in Knoxville, TN May 21<sup>st</sup> – 24<sup>th</sup>. They will be one of two teams representing the state of Massachusetts at the elementary school level for their DI "Tension Builds" challenge. Request for Declaration of Water Supply Conservation MOTION: I, Ms. Modica, move that the Board declare a state of water supply conservation in accordance with the General Bylaws, Section 226, Water Conservation and the Town's MDEP Water Management Act which requires the town to limit nonessential outdoor water use through mandatory restrictions from May 1, 2014 through September 30, 2014. Nonessential water usage is prohibited in the Town of Uxbridge between the hours of 9am and 5pm. Seconded by Mr. Anderson, the motion carried 4-0.
- 4. King Street Extension Road Closure Public Safety Fire Chief Bill Kessler and Mr. Brandon Kibbe with Transcanada were present and discussed the reasoning for the road closure. MOTION: I, Mr. Anderson, move that the Board approve the request to close King Street Extension based on the information provided by the Public Safety Committee. Seconded by Ms. Modica, the motion carried 4-0.
- 5. Right of First Refusal Assessor's Map 47, Parcel 1556, 1012 Hathaway Lane Mr. Anderson recused himself due to a conflict of interest and left the meeting room. Mr. Rick Hathaway was present and informed the Board of his intent to sell the property. MOTION: I, Mr. Baghdasarian, move that the Board not exercise the Right of First Refusal for 1012 Hathaway Lane. Seconded by Ms. Modica, the motion carried 3-0. Mr. Anderson returned to the meeting room.
