Present: Chair Jennifer Modica, Vice Chair/Clerk Jeff Shaw, Selectman Peter Baghdasarian, Selectman Tim Rice and Selectman Lance Anderson. Also present Town Manager David Genereux and Administrative Assistant Tracey Ante.

I. CALL TO ORDER

- 2. Citizen's Forum No one wished to be heard.

II. WELCOME

Discussion with Senator Ryan Fattman and State Representative Kevin Kuros
Senator Elect Ryan Fattman and State Representative Kevin Kuros were present and thanked the
Board for the invitation to attend the meeting. They wished everyone a Happy Holiday. Several
topics of discussion included legislative timelines, upcoming plans, renewable energy and utilities.
Both intend to hold monthly office hours. All are welcome. Ms. Modica will coordinate their
attendance at a future meeting for updates and/or questions.

IV. NEW BUSINESS

- 1. Central Fire Station Design Study Expenditure Taft Funds Chief William Kessler was present and discussed the project along with a power point presentation. An RFP was awarded to Donham & Sweeney Architects whom completed Phase I, which was a comprehensive site assessment. This assessment addressed space needs/program design and site evaluation. The next step is to move forward with Phase II the Schematic Design and updated cost estimate. The committee is looking for the Board to approve using additional expenditures from the Taft Fund in the amount of \$94,500 to move forward with this phase. Chief Kessler has had ongoing meetings with the Town Manager regarding the project including land acquisition, timelines for Spring Annual Town Meeting, ballot election and funding options. Following discussions, MOTION: I, Mr. Shaw, move that the Board approve the expenditure of Taft Funds for Phase II Schematic Design Study. Seconded by Mr. Anderson, the motion carried 4-1 (Mr. Baghdasarian opposed).
- 2. Redevelopment Blanchard School updated letters of support to Mass Historical and Mass Dept. of Community Housing Development Mr. Harry Romasco with the Uxbridge Housing Associates Board of Directors was present and updated the Board on the progress of

the redevelopment of the former Virginia Blanchard School (progress summary attached to the minutes). MOTION: I, Mr. Anderson, move that the Board authorize the Chair to endorse the letters of support for the Blanchard school housing project to Mass Historical Commission and Mass Dept. of Community Housing Development. Seconded by Mr. Shaw, the motion carried 5-0.

- 3. Acceptance Solar Pilot Agreement Terraform Solar XVII, LLC, 363 Quaker Highway (Wrona site) Town Manager, David Genereux reviewed the agreement with the Board. Slight revisions were recommended. The Town Manager will amend the agreement. MOTION: I, Mr. Anderson, move that the Board vote to approve a payment in lieu of tax (PILOT) Agreement with TerraForm Solar XVII, LLC for the installation of a 3.05 Megawatt DC ground mounted solar photovoltaic plant on 32.78 acres, more or less, located on 363 Quaker Highway, Uxbridge, MA (Assessors Map 35, Lot 4268), for a period of twenty years, four months with negotiated payments of \$22,027 in year one and \$66,082 for the remaining years, said agreement to be effective December 23, 2014 and ended on June 30, 2034. In approving this Agreement, the Board of Selectmen hereby authorizes the Town Manager to sign any other documents to effectuate this agreement. Seconded by Mr. Baghdasarian, the motion carried 5-0.
- 4. Acceptance Monetary Donation Council on Aging The Town Manager read the letter from Mr. Steven Janko who graciously donated \$250.00 to the Council on Aging. In his letter he expressed the importance and service the Council on Aging provides. MOTION: I, Mr. Anderson, move that the Board accept the monetary donation with thanks for the Uxbridge Council on Aging. Seconded by Mr. Shaw, the motion carried 5-0.
