Present: Vice Chair Jeff Shaw, Clerk Jim Hogan and Selectman Peter Baghdasarian. Also present, Town Manager David Genereux and Administrative Assistant Tracey Ante.

Not Present: Chair Jennifer Modica.

**I. CALL TO ORDER**

1. Announcements – The Fall Annual Town Meeting is Tuesday, 10/25 at 7pm at the Uxbridge High School. All are encouraged to attend.
2. Citizen's Forum – Mr. Justin Piccirillo advised the Board that he was proud of the support for the Special Election to fill the Board of Selectmen vacant seat. There are 3 candidates. He requested the Board support a debate. Board members welcomed the idea and suggested he contact the Cable Access Coordinator to make arrangements.

**II. NEW BUSINESS**

1. Planet Aid – Donation bins for clothing and shoes – There was general discussion. Board members requested a representative from Planet Aid attend their next scheduled meeting.
2. Review DEP Site Visit - Millville Road ACO – The Town Manager advised the Board that there was a site visit conducted with the DEP officials and Natural Heritage at 775 Millville Road. DEP anticipates finalizing the Administrative Consent Order in the near future. No votes or action was taken.
3. Appointment – Poll Workers – Judene Cahill, Robert Dandrade, Carol Dandrade  
**MOTION: I, Mr. Hogan, move that the Board appoint Ms. Judene Cahill, Mr. Robert Dandrade and Ms. Carol Dandrade as Poll Workers. Seconded by Mr. Baghdasarian, the motion carried 3-0.**
4. Pilot Agreement – 680 Hartford Avenue West – The Town Manager advised he is still waiting additional information to finalize the agreement. The Board passed over.
5. Endorse Fall Annual Town Meeting Warrant of 10/25/16  
**MOTION: I, Mr. Hogan, move that the Board endorse the Fall Annual Town Meeting Warrant of 10/25/16. Seconded by Mr. Shaw, the motion carried 2-1 (Mr. Baghdasarian opposed).**
6. Endorse Warrant for State Election 11/8/16  
**MOTION: I, Mr. Hogan, move that the Board endorse the Warrant for the State Election 11/8/16. Seconded by Mr. Baghdasarian, the motion carried 3-0.**
7. Endorse Warrant for Special Town Election 12/6/16  
**MOTION; I, Mr. Hogan, move that the Board endorse the Warrant for the Special Town Election 12/6/16. Seconded by Mr. Baghdasarian, the motion carried 3-0.**

8. Marijuana Facilities Discussion – Sargent Timothy Burke advised the Board that Chief Lourie and the Uxbridge Police Department do not support a marijuana dispensary or grow facility in the town. He informed the Board of his expertise in the field and the potential issues/problems associated with these facilities. He further advised that the DPH guidelines are preliminary and subject to change. There was general discussion. It was a consensus of the Board to not allow a dispensary or grow facility in the town.
9. Veteran’s Day Speaker – Ms. Modica will speak at the Veteran’s Day parade.
10. Application – Common Victualler License – Sweet Wise Hot Dogs, Main Street – It was noted that the application was received in the office today. The applicant would like to open for business tomorrow. The Board had no objection to allowing the applicant to open for business. The Board will formally vote at its next scheduled meeting.

**III. OLD BUSINESS**

1. Sewer Construction and Regulations (Acting as Water & Sewer Commissioners) – Mr. Benn Sherman, DPW Director was present and briefly discussed the regulations. **MOTION: I, Mr. Hogan, move that the board approve and endorse the Sewer Construction and Regulations. Seconded by Mr. Baghdasarian, the motion carried 3-0.**

Mr. Shaw adjourned the meeting at 7:18pm.


