## BOARD OF SELECTMEN'S EXECUTIVE SESSION MEETING MINUTES BOARD OF SELECTMEN'S MEETING ROOM 21 S. MAIN STREET, UXBRIDGE, MASS MONDAY, MARCH 27, 2017 – 6:30PM

## I. CALL TO ORDER

At 6:30PM, MOTION: I, Mr. Shaw, move that the Board enter into Executive Session to discuss and consider purchasing, exchange, taking, lease or value of property of 32 S. Main Street. Seconded by Mr. Hogan, the motion carried 5-0 by roll call vote (Modica – aye, Shaw – aye, Hogan – aye, Baghdasarian – aye, Piccirillo - aye).

## **II. EXECUTIVE SESSION**

32 S. Main Street - discuss strategy - consider purchase, exchange, taking, lease or value of property

The Town Manager advised the Board that Atty. Robert Knapik, representing the property owners of 32 S. Main Street, has contacted the office regarding the purchase and sale of the property. The owners are willing to sell the property to the town in consideration of One Hundred Two Thousand Dollars (\$102,000). It was noted that the property appraisal report is valued at \$65,000. Town Meeting action is required for the acquisition of the property. The Town Manager is seeking direction from the Board to see if the Board is willing to entertain the offer to purchase the property at said price. There was general concerns with the asking price, limited lot size and railroad easement. There is no recorded easement for the culvert to conduct the necessary repair work. Following further discussion, MOTION: I, Mr. Shaw, move that the Board accept the offer to purchase the property at 32 S. Main Street for \$102,000, subject to Town Meeting authorization. Seconded by Mr. Piccirillo, the motion carried 4-1 by roll call vote (Modica – aye, Shaw – aye, Hogan – aye, Baghdasarian – naye, Piccirillo - aye).
