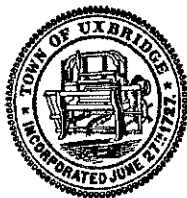

**I. CALL TO ORDER AT 7:00PM**

- A. Announcements – Ms. Robertson informed the public about [Nixle.com](http://Nixle.com). Residents may log on to the website to stay informed as to local police and community developments.
- B. Citizen's Forum – Mr. Ernie Esposito was present and commented on the criticism discussed on behalf of the SBC. He announced his support for the SBC and recognized their service and commitment. Mr. Esposito additionally recognized Mr. Baghdasarian's efforts for submitting a bill to name a bridge after Titus Ebbeling.

**II. PUBLIC HEARINGS/SCHEDULED APPOINTMENTS**

- A. Tax Classification Public Hearing – The Chairman opened the public hearing. It was noted the public hearing was correctly posted and published. Mr. Kuros read the statement. The public is invited to comment on the issue of tax levy percentages for FY 2010 for Residential, Commercial, Industrial and Personal Property. The Assessor will provide information and data relative to making a determination of the tax share of each taxable class. The Selectmen will determine whether or not to shift the burden of taxation among the classes. Ms. Paula Dumont, Assessor and David Genereux, Finance Director were present and discussed the Classification Recommendations in a memorandum dated December 21, 2009 (attached to the minutes). Following discussion and no public comment, the Vice Chairman closed the public hearing. **MOTION by Mr. Baghdasarian to set a single tax rate. Seconded by Ms. Robertson, the motion carried unanimously.** Mr. Genereux advised the Board, Kathy Reed, DOR Representative reviewed the Cap sheet and has no concerns. The rate will be finalized upon DOR notification which is anticipated shortly. Thereafter, notification will be published in the Telegram & Gazette and posted throughout Town. **MOTION by Mr. Baghdasarian, to authorize the Chairperson to endorse the letter granting an extension date for the mailings. Seconded by Ms. Robertson, the motion carried unanimously. MOTION by Mr. Baghdasarian to endorse the excess levy capacity of \$28,276.07 +/-.** Seconded by Ms. Robertson, the motion carried unanimously.



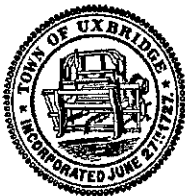

**III. TOWN MANAGER REPORT**

- A. Report – Meeting with Senator Moore and the SBA – The Town Manager updated the Board as to the meeting at Senator Moore's Office.
- B. The Town Manager announced Chief Scott Freitas was honored by his peers, elected and sworn in as President of the Police Chief's Association of Central Massachusetts. Congratulations to Chief Freitas.

**IV. OLD BUSINESS**

- A. Appointments – SBC subcommittee – **MOTION by Mr. Baghdasarian to appoint Ms. Keegan to the SBC subcommittee and that the Board appoint a member to be chosen by the Finance Committee to be a member of the SBC. Seconded by Ms. Pitman, the motion carried unanimously.**
- B. Planning Board Subdivision Rules and Regulations Overview – The Board had general discussions as relates to the PB Subdivision Rules and Regulations. Mr. Benn Sherman, DPW Director was also present. Discussion included plowing private ways, Planning Board and DPW responsibilities and/or involvement in the permitting process, void in the overall process, inspections, street maintenance, street acceptance policy, performance guarantee/bonding, unfinished subdivisions, developer responsibilities and bankrupt developers. Ms. Robertson suggested residents form a Homeowner's Association. Questions and discussion further included how to proceed in getting private way streets accepted and is it the Town's responsibility to chase developers, posting "private way" signs and money received from Chapter 90. Mr. Stephen O'Connell with Andrews Survey & Engineering was also present and commented on the Planning Board's responsibilities and follow thru, procedures, subdivision control, lot release, bonding requirements and early release of money. Attorney Joseph Cove was present and advised the Board as to the layout process, street acceptance policy, forming a LLC and other avenues to pursue to promote acceptance. The Town Manager will work closely with the Planning Board and the DPW Director to keep communication open amongst the Board and the Department. The Town Manager recommended monthly meetings and will provide a revised street acceptance policy for the Board's review. Mr. Baghdasarian identified typographical errors and areas of concern in the Subdivision Rules and Regulations. The Board will continue review and discussion at a future meeting.
- C. Update on Private Way Progress – Mr. Sherman updated the Board as to the private way progress. He recommended the Town seek a permit tracking system to monitor the permitting process. The Board has requested a prioritized list of possible street acceptance for next town meeting. It was discussed Serenity Drive was approved at Town Meeting 2006, however the deeds/easements and plans were not recorded. The

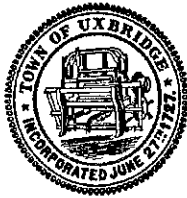

Office is still awaiting input from Town Counsel. Mr. Sherman updated the Board as to the status of Holbrook Farm Estates and Hammond Estates; whereas the Town is seeking money from the bond company for subdivision project completion.

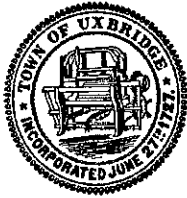
**V. NEW BUSINESS**

- A. Josselin & Lesser – High School Project update - Representatives from Joselin & Lesser and Representatives from Raymond Design, Architects were present and provided the Board with the history of the project and the current status. Most recently, a tour of all existing facilities was conducted to review further options. Joselin & Lesser is still awaiting a response from the MSBA. The Town Manager updated the Board as to the meeting at Senator Moore's Office with Representative Callahan, Representative Kujawski, local elected/appointed Officials, School Staff and School Committee Members and Representatives from the MSBA. It was discussed it was a productive meeting with an array of possibilities. He and Selectman Robertson recognized the cooperativeness on behalf of the MSBA and their suggesting a special meeting is very possible. It was further discussed the MSBA demonstrated a willingness to provide solutions to the Town to accommodate the space needs and accreditation. Specific details of the meeting were recommended not to be released as to not mislead residents. Mr. Baghdasarian noted there is no accreditation problem. Mr. George Zini, Supt. briefly discussed the meeting and the reasoning for maintaining confidentiality at this time. Ms. Pitman inquired as to the money allocated to Joselin & Lesser and if there were any over expenditures. Mr. Don Sawyer commented the work has been performed as contracted. He further requested the Board reconsider their formal action of withholding payment to Joselin & Lesser. He advised work has been performed and they have exceeded expectations. The Town Manager discussed withholding the payment due to concerns the MSBA had. The Town Manager will contact the MSBA and verify that there are no issues and proceed with release of payment if work was performed accordingly. The Board advised they did not take any formal action of withholding money and had no objections to releasing payment. It is the understanding of the attendees of the meeting, the MSBA will communicate with the SBC who will then present the specifics of the meeting to the public.

The anticipated project completion date is within 3 years. The Board requested input from the abutters. 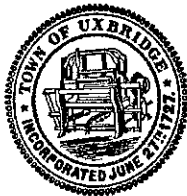



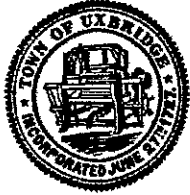

To the Honorable Board of Selectmen:

The purpose of tonight's hearing is to determine the percentage of the tax levy to be paid by the four different classes of property in the town. Traditionally, the tax rate has been the same for all classes of property in all but one of the last 25 years. That was in 1983 when commercial and industrial property was charge at a rate of 1.73 times as high as residential.

It is my recommendation tonight to use a single tax rate for all property classes even though the Board of Selectmen each year can exercise its right to shift up to 50% of the tax burden. Last year's rate was set at \$11.53 per thousand valuations. With a single rate this year, residential property owners represent 86.84% of the tax base, Commercial 4.99%, Industrial 4.83% and personal property 3.33%. The tax rate proposed for this year is \$12.55 per thousand valuations. This information is preliminary only and may have to be re-visited after the DOR approves our Preliminary and Final certification.

The new valuations represented an average decrease in value. When I mention average not all properties decreased in value or by the same percentage as various neighborhoods responded to market conditions differently. As always the markets (sales) are looked at from the previous year to allow for a full year of sales.

The average single family home value decrease from FY 2009 of \$323,500 to FY 2010 \$311,500. The average tax bill from last year was \$3,729 at \$11.53, this year \$3,900 at the \$12.55 rate. That is a \$179 or 8.9 % increase in taxes. New growth last year was \$399,700; this years new growth \$196,200. This was only due to the fact that even though the economy dropped we still had some new construction. Field inspections and local permits were the biggest help with the town's new growth.
