The Uxbridge Conservation Commission will hold a Public Hearing on Tuesday, April 19th at 7:00 PM in the Board of Selectmen's Meeting Room, Uxbridge Town Hall, 21 South Main Street, Uxbridge, MA, to review the following cases:

Four (4) Notice of Intent applications received for work under the jurisdiction of the Massachusetts Wetlands Protection Act (Chapter 131, Section 40 of the General Laws of the Commonwealth of Massachusetts) have been filed with the Commission by the following: 1) ExxonMobil Pipeline Company for a project located at Chocolog Road, Uxbridge, Assessor's Map 39, Parcel 3184. The proposed project involves polymer wrapping of existing petroleum pipeline. 2) ExxonMobil Pipeline Company for a project located Aldrich Street, Uxbridge Assessor's Map 45, Parcel 1073. The proposed project involves polymer wrapping of existing petroleum pipeline. 3) ExxonMobil Pipeline Company for a project located at Quaker Highway (Route 146A), Uxbridge, Assessor's Map 45, Parcel 2998. The proposed project involves polymer wrapping of existing petroleum pipeline. 4) ExxonMobil Pipeline Company for a project located at West Street, Uxbridge, Assessor's Map 32, Parcel 573. The proposed project involves polymer wrapping of existing petroleum pipeline.

Two (2) Request for Determination of Applicability applications for work potentially under the jurisdiction of the Massachusetts Wetlands Protection Act (Chapter 131, Section 40 of the General Laws of the Commonwealth of Massachusetts) has been filed with the have been filed with the Commission by the following: 1) Fairwoods Christian Recreation Society for a project located on 116 West Hartford Avenue Uxbridge, Assessor's Map 17, Parcel 861. The applicant is proposing to initiate a management program to manage nuisance aquatic vegetation and maintain the pond for its intended uses. 2) J.W. Audet, Inc. for a project located on 265 North Main Street Uxbridge, Assessor's Map 12C, Parcel 4366. The purpose of the application is to determine if any wetland resource areas are present within the property boundaries. The public meeting will be held on Tuesday, April 19, 2011 at 7:00 pm at the Uxbridge Town Hall, 21 South Main Street, Uxbridge, MA. Plans and specifications for these projects may be reviewed at the Conservation Office during regular business hours.
