CONSERVATION PUBLIC HEARING/MEETING NOTICES

The Uxbridge Conservation Commission will hold a Public Hearing on **Monday, May 6th, 2019** at 6:30PM in the Board of Selectmen Meeting Room, Town Hall, 21 South Main Street, Uxbridge, MA, to review the following application under the MA Wetlands Protection Act (MGL Ch. 131, Sec. 40). Plans may be reviewed in the Town Clerk's office during regular business hours.

NOTICE OF INTENT filed by Allen Engineering & Associates, Inc on behalf of Keith Armstrong of Downeast Realty for a project located at 39 Tabor Road, Assessor's Map 41, Parcel 1281. The project entails construction of a new single family house with associated grading and utilities in the buffer zone of a bordering vegetated wetland.

NOTICE OF INTENT filed by GHD, Inc. on behalf of the Town of Uxbridge DPW for a project located at 32 South Main St, Assessor's Map 25 Parcel 918. The proposed project is to replace a section of an existing masonry/rock culvert, install a deep sump catch basin, and install a parking lot in the previously developed property. The entire property is within the 200' riverfront area of the Mumford River, and a portion is within the 100' riverfront area.

NOTICE OF INTENT filed by Andrews Survey and Engineering on behalf of Milton Real Properties of Massachusetts, LLC for a project located at 126 and 148 Ironstone St and 64 Balm of Life Spring Rd, Assessor's map 50 parcels 827 and 835 and Map 51, parcel 147. The proposed project is for paving additional surfaces around an existing building including a second access from Quaker Highway, installing a new paved driveway and stormwater management features that will mitigate the increase in impervious surfaces. The project area is within the Riverfront Area of Bacon Brook and the buffer zone of a bordering vegetated wetland.

NOTICE OF INTENT filed by Kelly Engineering Group, Inc on behalf of Robert Demarco of Campanelli Uxbridge II LLC for a project at 100 Campanelli Drive, Assessor's map 28 Parcel 1746. The project is an approximately 132,300 square foot greenhouse and processing center in a portion of Lot 2 with associated parking, loading, and drainage in the buffer zone to a bordering vegetated wetland.
