1. No Meeting Minutes

2. Fall Annual Town Meeting Public Hearing

The Finance Committee reviewed the following articles, allowing town officials and citizens to speak about any of the articles.

Article 15 – Amend Home Charter Rule: This very lengthy article was split into the 8 articles of the Charter for review.

Harry Romasco, Chair of the Charter Review Committee, walked the Finance Committee through each of the proposed changes. A full copy of the Charter and proposed changes is part of the Fall Town Meeting Warrant.

- Article 1, Sect.3 removes a redundant paragraph.
- Article 2 seeks to clarify the composition of the Finance Committee. Sect. 4 clarifies Town Meetings as two each year. Sect. 7 makes the changes to be identical to MGL.
- Article 3, Sect. 1 seeks to make the Board of Health elected, not appointed.
- Article 3, Sect. 3 seeks to clarify the role of the Board of Selectmen in association with Charter adoption.
- Article 3, Sect. 6 seeks to clarify the number of elected Library trustees.
- Article 4, Sect. 1 seeks to remove transitional language. Sect. 2 seeks to add a section referring to appointments by the Town Manager.
- Article 5, Sect. 1 seeks to clarify media notification
- Article 6 Financial and Fiscal Procedures has several proposed changes/clarifications. Sect 8 seeks to strengthen the importance of the Capital Planning Committee.

- Article 7, Sect. 6 seeks to establish when and how the Charter will be revised. Sect. 7 seeks to clarify meeting agendas be posted at least 48 hours before any meeting.
- Article 8 contains all transitional provisions. Upon acceptance of the above changes, Article 8 will be deleted in its entirety.

Article 16 – Street Acceptance of Sand Wedge Drive – at the time of the meeting, appropriate paperwork was not finished.

Article 17 – Street Acceptance of Murphy's Way – no information available for the Finance Committee.

Articles 18, 19, and 20 are all rezoning articles. No one spoke to them.

Fire Chief Bill Kessler spoke about article 8 – Ambulance Chassis, and article 9 – First Aid revolving fund, providing additional details on both.

Articles 2 and 3 have not been reviewed as no numbers are available.
