1. Public Hearing - Spring Annual Town Meeting May 9, 2017 Warrant Articles

Article 17: Excavation and Filling projects

Barry Desruisseaux, representing the Planning Board spoke to the merits of the article, including the separation of excavation and filling regulations.

Article 4: Town Budget

Dr. Fitzpatrick, BVT Superintendent, provided an overview of the FY18 Regional School budget request. Uxbridge enrollment is down by 16 students and the budget represents a reduction of \$106,490.

Article 10: Capital Purchases/Article 13: Library Transfer from Stabilization/Article 4: Town Budget

Trustees Chairman Mark Francis and Library Director Ann Thomas provided information regarding the repair/replacement of the skylights. The funding will come from the stabilization account. The library budget is being increased by 10.1%, which will eliminate the need for a Massachusetts Library Board of Trustees waiver.

Article 4: Town Budget/Article 10: Capital Purchases/Article 5: School Department Contingent Appropriation

Superintendent Kevin Carney, Business Manager Brian Hyde and School Committee Chair Debbie Stark presented the FY18 school budget. The SC Chair spoke to the override proposal of a 1.32 million dollar increase over 2 years. Technology Director Patrick Mistler addressed the technology needs that would be funded by a portion of the override amount.

Residents Holly Black, Susan Dauphin and an unidentified woman provided comments regarding the FY18 School Department budget and contingent appropriation.

The Finance Committee Chair continued the Public Hearing to April 6, 2017 at 6:30PM.
