

- 1. FY19 Year End Transfers
 - a. Finance Professional Services
 - i. May 14th to June 18th extension request for Accounting and Treasury support
 - ii. Request for \$10,000
 - b. Information Technology
 - i. Mandatory upgrade of Town Website by CivicPlus to a Drupal platform at a cost of \$3k
 - ii. Stipend assigned to IT Director of \$12k to assist with upgrade
 - 1. Discussion on lack of transparency in calculation of stipend expenditure
 - c. Interim Town Manager Salary
 - i. \$11,250 for May 28th to June 30th
 - d. Acting Town Manager Stipend
 - i. \$3,000 for the Police Chief acting as Acting Town Manager
 - ii. Discussed calculations for dollar figure was the difference between expected Town Manager hourly rate and Police Chief hourly rate
 - e. Town Manager Vacation Payout
 - i. \$9,501 vacation payout for the Town Manager
 - ii. Questions were asked as to why this wasn't negotiated as part of the separation contract

 - a. Article 5 Capital Purchases
 - i. Discussed the Capital Committee not getting backup they requested
 - b. Article 7 Establishment of Ambulance Receipts Reserved for Appropriation Account

- i. This is to create a self-funding account to replace an ambulance every three years
- c. Article 9 Wastewater Enterprise Fund Budget
 - i. Moved debt into the Enterprise Fund
 - ii. Was informed this had already been calculated in the rates
- d. Article 10 Water Enterprise Fund Budget
 - i. Discussed delta of \$10k more debt than is on the short form, Interim Finance Director to follow up
- e. Article 8 Town Budget
 - i. Reviewed documents that were provided by Interim Town Manager and Interim Finance Director
- 3. Public Hearing Special Town Meeting June 18, 2019 Warrant Articles
 - a. Article 5 Highway Stabilization Override
 - i. Discussed that that this was a yearly article to ensure \$400k was set aside for road repair using our excess levy capacity
 - b. Article 1 Disposition of Surplus Town Owned Property McCloskey School
 - i. McCloskey will be broken into three parcels owned by the town
 - c. Article 2 Transfer of Funds McCloskey
 - i. Transfer of funds to cover the expenses of the school transferred from the School to the Town
