b) Discussion of results of Town meeting and how we can improve our messaging.

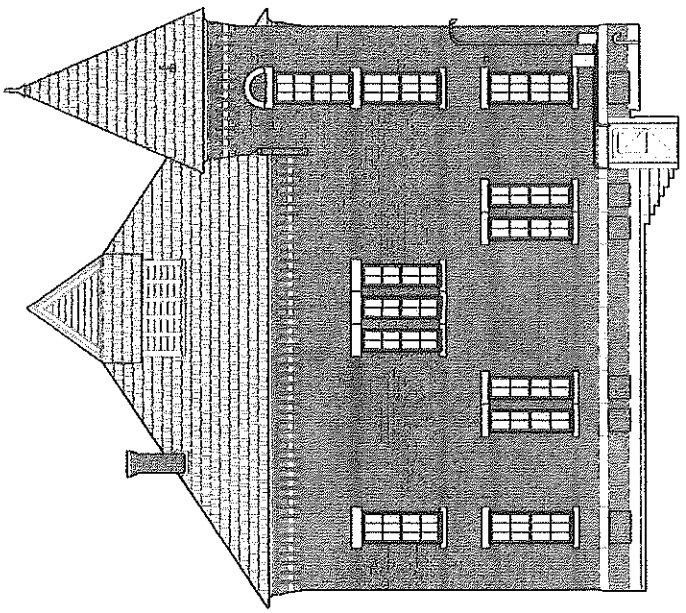
Next meeting will be June 13, 2018 at 5:30 P.M. in the Lower Town Hall.

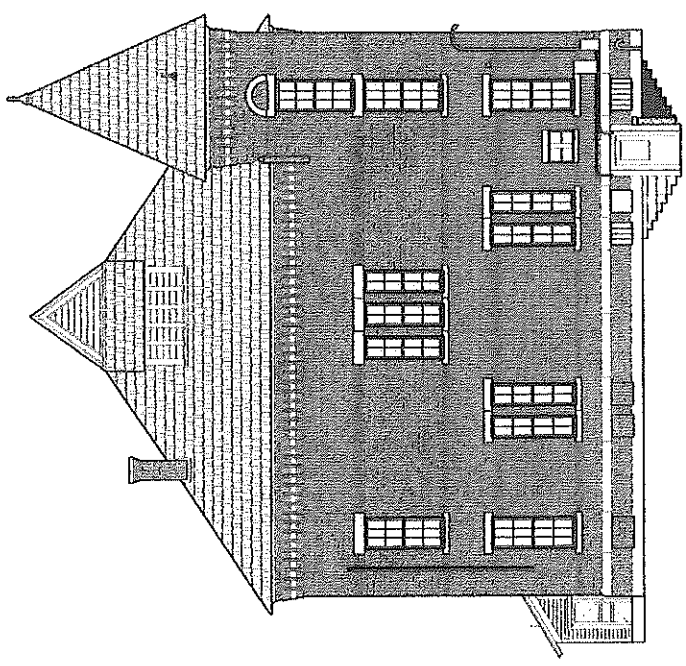
