Minutes of the Uxbridge Town Manager Review Committee meeting on November 16, 2017 in the Selectmen's meeting room, Uxbridge Town Hall, 21 South Main Street, Uxbridge, MA

- I. The meeting was called to order at 3:00 p.m.
- II. Item IV on the meeting agenda was moved up in the meeting in order to approve the minutes from the previous meeting of November 15, 2017. Chief Lourie **MADE A MOTION** to approve the minutes for November 15, with a **SECOND** from Mr. Federico. The minutes were unanimously approved.






