Minutes of the Uxbridge Planning Board regular meeting held on Wednesday, November 10, 2010, at 7:00 P.M. in the Board of Selectmen's Room, Uxbridge Town Hall, 21 South Main Street, Uxbridge, MA:

It being 7:00 pm, the meeting being properly posted, duly called and a quorum being present, Chairman Charles Lutton called the meeting to order and led the gathering in the Pledge of Allegiance.

FY-11-01 Conservation Design - Vanderzicht, Application for a Definitive Plan Approval & a Special Permit Application cont'd - The owner of record Vanderzicht Realty Trust and Keith & Sherri Vanderzicht and applicant of record Carol Hansen are seeking a Definitive Plan Approval & Special Permit for Conservation Design - Vanderzicht, located on the east by Rawson Street and on the south by Williams Street. The property has seven (7) proposed lots and is shown on the Town of Uxbridge Assessor's Map 10, Parcels 2959, 3393, 3625 & 3645. The plan is recorded in the Worcester County Registry of Deeds Plan Book 15031, Page 61. Mr. Stephen O'Connell with Andrews Survey & Engineering sent a letter as a formal request to continue the public hearing at the next scheduled public hearing of the Planning Board. Following discussion, MOTION by Mr. Desruisseaux to grant a continuance FY-11-01 Conservation Design - Vanderzicht, Application for a Definitive Plan Approval & a Special Permit Application to the next scheduled Planning Board meeting on December 8, 2010. Davis Heights (Glen Street & Lee Street) – The Planning Board office received documentation from Doherty, Ciechanowski, Dugan & Cannon, P.C. dated November 1, 2010 demanding the return of the entire bond to Marinella Construction. Following discussion, MOTION by Mr. Desruisseaux to return the entire bond to Marinella Construction, LLC. Seconded by Mr. Leonardo, the motion carried unanimously. Following discussion, MOTION by Mr. Desruisseaux to forward a letter to Mr. David

Genereux, Finance Director for the Town of Uxbridge to reduce bond to zero for Glen Street and Lee Street at Davis Heights. Seconded by Mr. Leonardo, the motion carried unanimously.
