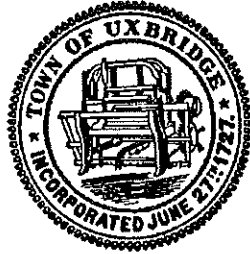

 4. David will contact BOH in Attleboro regarding their regulations.


Actions:


1. The FB page will be administered by Christine and Mary.
2. Linda and Orlando will develop survey questions.


The meeting was adjourned at 7:45 PM.


