**2. River Rd.**

Discussed: Uni-Tran is the main user of River Rd and this is an unapproved dirt road with many pot holes and DPW cannot commit to spending \$30k to \$40k a year for up keep to grate the road and fill in the pot holes every year. Environmental permitting is needed in order to pave this road and then the town will need to design a roadway with the entire infrastructure because you will be in wetlands and will cost about \$200,000 just in paving costs for River Rd.

He will need 1 cruiser and 1 Officer for this detail which will begin at 11:30 am and end at 7:30 p.m.


