I. CALL TO ORDER

II. OLD BUSINESS

1. Approval of Minutes:

III. NEW BUSINESS.

1. 3rd Annual Bank Concert – Town Park, Marywood Street

The First Night Committee is having their 3rd annual concert at Taft Park on Sunday, September 25, 2016 from 2:00 p.m. – 6:00 p.m. They are requesting additional trash containers and a police detail for the event.

2. Drought/Water Supply Update

Benn Sherman says the wells are running hard. For the most part people are following the current water restrictions, which is a full ban on nonessential outdoor water usage. The Water Dept. will be driving through town during evening hours to check if there are residents violating the current water restrictions.



3. **Greenway Challenge – September 24, 2016**

After a review of the course segments presented by Charles Thompson, Chief Lourie has asked Sergeant Burke to coordinate police details to cover the course route.

4. **PSC Member Status – Peter Emerick**

David Genereux will contact Peter, who is also the Emergency Management Director for the Town and see if he can attend the Public Safety Committee meetings on a quarterly basis. To be discussed further at an upcoming meeting.

5. **South Main Street Pedestrian Safety – Crosswalks**

Chief Lourie received correspondence requesting barrels. There is concern that the cross section in the center is too narrow for the barrels. Chief Lourie would like to perform a traffic assessment. David Genereux will look into seeing if two parking spots could be removed. **Motion by Jeffrey Lourie, seconded by William Kessler in favor of the removal of parking spaces before the approaching traffic. Motion carried 5-0-0.**

6. **Handicap Parking at Pout Pond**

Benn Sherman will review and report back to the committee if it is code to have designated parking signs.

IV. **Adjournment**


Motion by Benn Sherman, seconded by Jeffrey Lourie to adjourn the meeting at 11:03 a.m.
