### **I. CALL TO ORDER**

It being 9:07 am, the meeting being properly posted, duly called and a quorum being present, the meeting was called to order by William Kessler.

### **II. OLD BUSINESS**

#### **1. Approval of Minutes:**

**Motion by Jeffrey Lourie, seconded by Benn Sherman to accept the minutes of the May 17, 2017 Public Safety Committee Meeting. Motion carried 3-0-1. Kevin Carney abstain not present at the May meeting.**

### **III. NEW BUSINESS**

#### **1. Snow Clearing at Taft School.**

Stacey Pominville addressed the Committee in reference to the snow that is being piled by the north entrance to Taft School. Benn Sherman said the biggest issue is snow removal. Bill Kessler suggested that Benn put in the contract that they leave a 3 foot clearance for students to walk. Benn said they can ask them to clear the whole section. Benn Sherman will update contracts and send them out by Friday, August 25<sup>th</sup>. If there are issues contact Benn Sherman.

#### **2. Greenway Challenge to discuss race route and details.**

Charlie Thompson presented the Committee with times of the run, cycling and paddling. Mr. Thompson requested three details for three separate locations. It was established that in the future if there is a police detail request Mr. Thompson can contact Chief Lourie.

#### **3. Library's "Chalk the Walk" fundraiser.**

**4. Discuss and vote on Town Common Use for Cultural Fair on September 30.**

Cindy Scott submitted a Release form for use of the Town Common. Bill Kessler informed her there are to be no stakes in the ground due to sprinklers. Chief Lourie said he did not have an issue with this event. At this time they do not need a detail Officer because they are not closing Court Street.

**6. Update Crash Data where signs were put up.**

Chief Lourie to ask Lead Dispatcher, Joe Lefebvre, to pull statics on accidents at the three (3) locations where the new stop signs went up. Chief Lourie will get statistics on accidents 2 years prior to the lights being in place at the following intersections; Rivulet St. - West Harford Ave., Douglas Pike - Aldrich St. and Granite St. - E. Harford Ave. intersection. Joe Lefebvre will also run statistics on accidents from the time the new lights went in up to present day.

**IV. Adjournment**


Motion by William Kessler, seconded by Benn Sherman to adjourn the meeting at 9:52 a.m.


