1. Executive Session -Open Contract

Eileen Gorman stated that she felt it was unfair that she wasn't able to vote on the contract if it were tabled.

Ms. Taparauskys stated that she would compile the list of questions made by Committee members regarding the evaluation and contract of the Superintendent and would get back to everyone.






