1. Call to Order-

Michelle Taparousky, Chair, called the meeting to order at 7:00pm.

2. School Committee Reorganization

Michelle Taparousky nominated Melanie King to be Chairman. Sean Dugan seconded the nomination. The Committee voted in favor of said nomination 6-0-1. Jane Keegan abstained from the vote. Melanie King became the new Chairman.

Ms. King provided examples and explanation of why she was well suited to be Chairman, including overseeing a multi-million annual charitable golf tournament, familiarity with Robert's Rules of Order, and having completed training hours with the Massachusetts Association of School Committees with plans to attend more.

Charlene Miller thanked Ms. Taparousky for her time as Chairman. Sean Dugan added that he appreciated the increased level of communication from the year prior.

Debbie Stark nominated Sean Dugan to be Vice Chairman. Jennifer Modica seconded the nomination. The Committee voted in favor of said nomination 7-0-0. Sean Dugan became the new Vice Chairman.

Mr. Dugan stated that he felt it was unorthodox to have to justify nominations for Chairman and Vice Chairman to a single Committee member, but explained that although he was younger, he had experience through student government, being Chair of the budget subcommittee, and working full time for an elected board in a larger municipality.

No nominations were made for Secretary of the Committee. Ms. Taparauskys explained that nominations could be taken at the next Committee meeting

3. Adjournment




The Committee adjourned at 5:17pm.




