Timber Harvesting Ordinance

Jim Eckert, District Forester, answered questions and discussed the following with the Board:

- 1) Purpose of Ordinance.
 - Chm. Cronan and Tw. For. Wardrop explained background;
 - Purpose deal with high-grading of wood lots.
- 2) High-grading unenforceable
 - Discussion: quality of stump not indication of stem;
 - Tw. For. Wardrop noted baseline for before-and-after harvest provided in amendment.
- 3) Recommendation: "Management Plan" amended to read: "Harvest Plan".
 - expense of management vs. harvesting plans
 - S. Malis-Andersen 60% volume removal each 5 years?
 - Not economically viable quality of trees drive harvest, not volume;
 - Volume controls maintain water quality in Shore Land Zoning;
 - ---- detrimental for Town-wide forest management;
 - Current Draft : requirements as forest harvesting plan suitable.
- 4) District Forester role as 2nd opinion on Harvesting Plan? J. Eckert will look into this question and report back to Chairman.
- 5) Comprehensive Plan issues vs. Land Use Ordinance.
 - Harvest area size;
 - intervals;
 - Checks and balances;
 - Role of Forest in the Community.
- 6) Harvest Plan requirements forester's responsibility.
 - Significant wildlife habitat is mapped in Veazie;
 - Diverse habitat in Town by nature;
 - Species change as habitat changes;
 - expectation of land owner: check for known occurrences.

Timber Harvesting Ordinance (cont.'d)

Town Attorney notes –

- Comprehensive Plan can support anything;
- Need land conservation goals;
- "purpose" not a standard.

Sustainability -

- several agencies different certification;
- acceptable list of standards?

Resolved: Conclude Harvesting Ordinance issue at next meeting with more Planning Board members present.
