## 2) Open Space Ordinance Update

Legal Opinion

- C. Cronan thanked Atty. Russell for his work
- Atty. Russell provided follow-up explanations of Court Rulings.

Chm. Cronan moved to approve setting a public hearing to encourage public comments on the proposal at the 9 August meeting; seconded: K. Carr; voted unanimously.

### 2) Timber Harvesting Ordinance

Don MacKay, Town of Veazie Conservation Commission Chair, discussed the proposal with the Board.

- 4<sup>th</sup> 5<sup>th</sup> such discussion previous years' discussion on the Commission
- Flexibility hi-grading vs. clear cutting
- Limits Jim Eckert, District Forester, suggested 60%.

### Bd. Mber. S. Malis-Andersen noted these following -

- Forest cover interruptions due to subdivision development
- Wet soils affected by tree-cutting
- Wet cellars since Hillside Drive developed problems
- Land Use Regulations "hydrologic drainage... Protect lands from flooding..."
- Landscape level impacts.

- Scientific- based impacts of timber harvesting studies available?
- Plan integrating impacts on watershed
- % of harvest vs. level of impact

The consensus of the Board is to seek other examples of municipal timber harvesting ordinances with the intent to:

- a. provide standards for review of forest harvest plans;
- b. allow for Planning Board or Town Council review of extensive harvesting; and
- c. respect the developed nature of Veazie's once uninhabited backlands.

Other Business: J. Manter provided copies of Kenebec Valley Council of government's Model Open Space Ordinance by Fred Snow, Staff planner, to the Board members and Town Attorney
