1. Meeting called to order at 11:05am

Powilatis recommended reorganization:

- b. Powilatis suggested in the future that the director will no longer be able to sign checks. All bills and payroll would be signed only by board members, Powilatis and Hall until Mr. Santos signs forms at the bank. Voted 3-0-0
- c. Check made out to Pam for hours in July. Powilatis asks for a motion to hold Pam's check until the board gets more information as the status of WHA at the time of her abrupt departure on 7/22/13. Rudy made motion, Bob seconds the motion. 3-0-0 Powilatis also would like to hold all payments that have sales tax check all before sending them out because the authority is sales tax exempt as well as not pay balances forward. - e. Contact Powers and Sullivan CPA as well as Executech to come in to Wareham Housing Authority. Powilatis would like a motion to be made to contract Powers and Sullivan CPA to perform a transition audit, Santos made motion and Hall seconds the motion. Voted 3-0-0.
