The board signed monthly reports and exemptions.

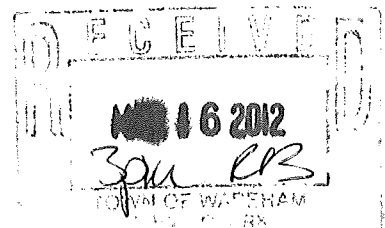
Motion made, seconded and voted 3-0-0 to adjourn at 3:28 PM.
