A motion was made by Priscilla and seconded by Steve to abate application number 9. The Board voted 2-0-1 with Roxanne abstaining due to conflict of interest. A motion was made by Priscilla and seconded by Roxanne to deny applications 75, 76, 77, 78, 80, 81 and 82. The Board voted 3-0-0. A motion by Priscilla and seconded by Steve was made to deny applications 76, 105 thru 113. The Board voted 2-0-1 with Roxanne abstaining due a conflict of interest. A Motion was made by Roxanne and seconded by Steve to deny application 87. The Board voted 2-0-1 with Priscilla abstaining due to the applicant being a friend. There were three members present as a majority to open a meeting and the votes of 2-0-1 are a majority of the Board. A motion was made by Priscilla and seconded by Roxanne to abate Personal Property applications 11P thru 14P. The Board voted 3-0-0.

The next meeting of the Board is Thursday March 12, 2015 at 5:00 pm.


Motion was made and seconded to adjourn, the board voted 3-0-0 at 6:43 pm.
