Mr. Ethier described to the Board, violations of the Massachusetts State Sanitary Code "Chapter II" Minimum Standards of Fitness for Human Habitation. State Sanitary Code violations include rubbish, debris and open garbage bags scattered under back stairs, and along the back and side of property. After brief discussion, the Board voted to fine the Carnes in the sum of \$250.00 payable to the Town of Wareham.

### 4:10 p.m.- Barnstable County Dept. of Health & Environment, Regulations and Agreement- I/A System Monitoring Program

Mr. Brian Baumgertel, Barnstable County Department of Health & Environment and Ms. Rachel Jakuba, Vice President, Coalition for Buzzards Bay, approached the board to pursue a vote from the members to enforce a tracking program regarding comprehensive waste water planning within the Town of Wareham. The board members have researched this project and have discussed the possibilities of enforcement. After further discussion, the Wareham Board of Health voted to pursue and enforce 310 CMR 15.00 (Title 5) and to

facilitate (I/A Tracking Program) comprehensive wastewater planning within the Town which requires that all owners or operators of innovative alternative (I/A) onsite septic systems comply with all operation and maintenance requirements set for the by the Wareham Board of Health. Further, the Board of Health requires that any person or entity who owns, operates, maintains or monitors I/A septic systems shall register and report all findings of operation and monitoring by the means and methods designated by the Barnstable County Department of Health and Environment. A receipt of said registration shall be required as part of the application for a Disposal Works Construction Permit. Registration for All Onsite Systems: The Board of Health of the Town of Wareham, pursuant with its responsibility to enforce 310 CMR 15.00 (Title 5) and to facilitate comprehensive wastewater planning within the Town, seeks to compile information regarding onsite septic systems in a usable retrievable format. Accordingly, under the authority of M.G.L. Ch. 111 Sec 31, the Board of Health requires that all applicants for Disposal Works Construction Permits for subsurface sewage disposal systems within the Town of Wareham register selected details regarding the application with an online database maintained by the Barnstable County Department of Health and Environment. A receipt of said registration shall be required as part of the application for a Disposal Works Construction Permit. The Wareham Board of Health voted this regulation to go into effect immediately.

On a motion of Dr. Wiegandt and seconded by Mr. Monterio, the Board voted a "Title 5, I/A Tracking Program" regulation will go into effect immediately.

On March 20, 2013, the Wareham Board of Health voted to pursue and enforce 310 CMR 15.00 (Title 5) and to facilitate (I/A Tracking Program) comprehensive wastewater planning within the Town which requires that all owners or operators of innovative/alternative (I/A) onsite septic systems comply with all operation and maintenance requirements for the proposed technology that are set forth in the Massachusetts DEP Approval Letter and any additional monitoring or maintenance requirements set forth by the Wareham Board of Health.

Further, the Board of Health requires that any person or entity who owns, operates, maintains or monitors I/A septic systems shall register and report all findings of operation and monitoring by the means and methods designated by the Barnstable County Department of Health and Environment. A receipt of said registration shall be required as part of the application for a Disposal Works Construction Permit.

Registration for All Onsite Systems:

The Board of Health of the Town of Wareham, pursuant with its responsibility to enforce 310 CMR 15.00 (Title5) and to facilitate comprehensive wastewater planning within the Town, seeks to compile information regarding onsite septic systems in a usable retrievable format. Accordingly, under the authority of M.G.L. Ch. 111 sec. 31 the Board of Health requires that all applicants for Disposal Works Construction Permits for subsurface sewage disposal systems within the Town of Wareham register selected details regarding the application with an online database maintained by the Barnstable County Department of Health and Environment. A receipt of said registration shall be required as part of the application for a Disposal Works Construction Permit

On March 20, 2013 the Wareham Board of Health voted this regulation will go into effect immediately.
