The proposal has no age limit and five (5) will be affordable and the price cannot be established at this time and can only guess they will be around \$170,000. Discussion ensued.

H. <u>TOWN ADMINISTRATOR'S REPORT</u>

Mr. Sanguinet advised the Board of Selectmen that it was him that released the draft meeting minutes and apologized for any embarrassment it may have caused the board.

Mr. Sanguinet also advised the board that he has a copy of the map of the Memorial benches that the board had requested at a previous meeting.

Mr. Sanguinet moved the board to approve the election warrant.MOTION: Selectmen Eckstrom moved to approve the election warrant as presented.Selectmen Donahue seconded.

<u>Commercial Oyster and Soft Shell Clam Fisheries.</u> The Board is asked to approve the Soft Shell Clam and Oyster regulations for the coming season (refer to attached report from Michael Parola, Harbormaster/Shellfish Constable). The Commercial Oyster regulations are in effect December 1, 2008 through March 31, 2009, and no changes are being recommended this year from prior years.

The Commercial Soft Shell Clam regulations run November 1, 2008 through April 30, 2009. There are no recommended changes from last year.

Recommended action. Motion for the Board to approve the Commercial Oyster regulations effective December 1, 2008 to March 31, 2009, and the Commercial Soft Shell Clam regulations effective November 1, 2008 to April 30, 2009, in accordance with the provisions of MGL Chapter 130, Section 52, per the attached regulations.

MOTION: Selectmen Eckstrom moved the board to approve the Commercial Oyster regulations effective December 1, 2008 to March 31, 2009, and the Commercial Soft Shell Clam regulations effective November 1, 2008 to April 30, 2009, in accordance with the provisions of MGL Chapter 130, Section 52, per the attached regulations. 2. <u>Establishment of Management Area #4—East River and Broad Cove.</u> The Board is asked to approve the establishment of East River and Broad Cove as

shellfish management area #4 effective November 1, 2008. This will allow the Town to properly manage the shellfish received under the relay program sponsored by the Division of Marine Fisheries. There have been 1,350 bushels of quahogs planted by the Shellfish Department over the last two years and managing the allowable harvest will help ensure years of productive shellfish beds.

Recommended Action. Motion for the Board to declare the following described portion of Onset Bay Management Area #4, subject to special regulations, in accordance with the provisions of Chapter 130, Section 52 of the Massachusetts General Laws:

"East River and Broad Cove: The conditionally approved waters and flats of that portion of Onset Bay, North of the Onset Avenue Bridge, and easterly of the Main Avenue Bridge (Dummy Bridge)."

MOTION: Selectmen Eckstrom moved the Board to declare the following described portion of Onset Bay Management Area #4, subject to special regulations, in accordance with the provisions of Chapter 130, Section 52 of the Massachusetts General Laws:

"East River and Broad Cove: The conditionally approved waters and flats of that portion of Onset Bay, North of the Onset Avenue Bridge, and easterly of the Main Avenue Bridge (Dummy Bridge)." Selectmen Donahue seconded.

3. **<u>FY09 Budget.</u>** Director of Assessing, Richard Gonsalves, has provided me with a new estimate for New Growth of \$665,000. I would suggest that the Board vote to amend the budget being presented to Town Meeting, restore the Assessing Clerk's position to full time, and restore the full time custodian's position. The Warrant and the Budget will be published in this week's Observer. I have not restored many of those items that I would have liked to due to the concern with possible reductions in State Aid. My understanding from MMA and the discussion with Senator Pacheco is that the Governor may request additional reductions in November. It is my hope to offset those cuts through this increase. A 1% reduction in our Local Aid equals \$167,000.

Recommended Action. Motion for the Board to amend the Assessor's Line item from \$272,462 to \$279,456 and to amend the Public Buildings Wages from \$195,223 to \$211,766.

(This was done earlier in the meeting)

4. <u>First Quarter Reports</u>. Attached are the revenue and expenditure reports. The Revenue report is for July and August, the final September numbers are not available until mid October. The Expenditure report is for July, August, and

September. I have asked those departments that have expended more than 30% of any one item to give me an explanation for this.

- 5. <u>Onset Police Investigation</u>. The Bristol County DA is investigating the incident that occurred in Onset. According to that Office an Active investigation is continuing and they would not divulge any additional information. It is their hope to have a final report in the not too distant future.
- 6. <u>SRPEDD Traffic Review.</u> I have spoken to Roland Hebert at SRPEDD regarding the River Run and the Retreat at Union Pond. He was looking into whether SRPEDD had commented on the River Run Project and will not have an answer until this week. I will update you at the meeting. I have sent him the Traffic Study report for the Retreat at Union Pond and they will review that for us. If the Town would like them to complete a full traffic analysis a letter from the Board is required. I have included a letter for you to sign.
- 7. <u>Donation of Two Prints.</u> Mr. Richard Wadsworth donated two prints of Wareham Narrows Circa 1850. Both prints are currently in the Selectmen's Office. I will be talking to the Historical Commission to determine a suitable location for them.

MOTION: Selectmen Ekcstrom moved the board to accept the donation of the two prints. Selectmen Donahue seconded.

The Town submitted the material requested for the Hearing held on September 10^{th} and the Hearing was closed on September 24^{th} .

- **9.** <u>South Coast Rail Technical Assistance Program.</u> I have completed the application (included in this report) for Technical Assistance being offered by EOT. It needs to be signed by the Chair.
- **10.** <u>W/S Development Agreement.</u> The Town has received the second installment of W/S's Agreement with the Town.
- **11.** <u>Sign Enforcement.</u> Attached is a memo I sent to the Director of Inspectional Services, Ted Misiaszek, regarding enforcement of the sign by-law.

- The homeowner shall install a pump chamber with a grinder pump with automatic controls including but not limited to a high level alarm, and automatic level controls at his/her expense;
- The homeowner shall also incur all costs associated with the installation of all piping required to connect to the Town's collection system;
- The homeowner shall maintain the operation of the pumps including but not limited to, operation costs, repair and maintenance costs and in the event there is a pump failure due to mechanical failure or loss of power, the homeowner shall be responsible for having the contents of the 1000

gallon pump chamber removed by a licensed septic hauler and will bear all costs associated with pumping and disposal;

- The homeowner shall hire a licensed drainlayer to perform this work per plans submitted by JC Engineering, Inc.;
- Prior to backfilling, all cleanouts, pipe and connections shall be inspected by the WPCF department and an as-built drawing shall be submitted by the contractor/engineer upon completion;
- All cuts within existing paved roadways shall be inspected and approved by the director of Municipal Maintenance.
