The Board of Selectmen held a public hearing, under G.L. c.85, §3, 3B, to consider whether to change the names of two streets, which now are known as Wankinco Avenue and Wankinquoah Avenue.

Present before the board: George Barrett, Chairman of Planning Board Mr. Barrett said that an intern from the Planning Board was giving a task to find Duplicate Street names and feels that this might have started the name change.

Present before the board: Peter Murphy, Senior Dispatcher 911 Supervisor Mr. Murphy stated that the streets proposed to the intern and the planning board to change was the Wankinquoah in Swift's beach and in Cromesett. Mr. Murphy stated that in the past when a 911 call came in they use to have to ask if they were located in Swifts Beach or Cromesett.

Present before the board: Kathy Allard & Ms. Allard's Attorney The Attorney feels that the entire problem started with the putting up of a bad sign Ms. Allard has a petition signed that 4 out of the 6 people on the street don't want the street name to be changed to Oceanside. Ms. Allard also suggested that perhaps placing under the street sign the house numbers along with arrows. Present before the board: John Collins Mr. Collins lives on Wankinquoah and stated that he does not understand why the board is holding a hearing tonight after a decision has already been made by an Administrative Law Judge.

Ms. Bronk said that the town does need to have a capital plan even if it causes a reduction in staff and the town needs to put aside some money into a fund. Mr. Trudell said the town needs a capital plan and is frustrated that one is not in place and would like to have a rough plan ready for next Town Meeting.

SELECTMEN BUSINESS

- 1. **<u>FY2010 Budget:</u>** I met with staff Tuesday, November 25 to begin the budget process. At this meeting I told them that 2010 would be as bleak as the last three months have been. My direction to them was to budget at level service as funded in the FY08 Spring Town Meeting budget, and once I get a better grasp of what State Aid reductions will be I can make adjustments. Several departments will be receiving special instructions from me on their budgets. I handed out a template personnel sheet that I asked them to use.
- 2. <u>Wicker's Inn/Harborwatch Inn.</u> The Town has provided the Commonwealth of Massachusetts Department of Revenue with the renewal information for this license.
- 3. <u>Letter of Gratitude.</u> The Town received a letter from Chief McDuffy, commending the Chief of Police Tom Joyce, Sgt. Kevin Walsh, Lt. Irving Wallace, and Lt. Arthur Brightman, as well as Mark Gifford of Municipal Maintenance, for their assistance with the incident that occurred October 22, 2008 regarding a tanker truck. These men, as well as all Town staff who assisted in this incident, should be commended for their diligence in preventing what could have been a catastrophic event.
- 4. <u>**Pit Bull Report</u>**: The Chief of Police has provided a report on all incidents with pit bulls. Please let me know when you would like to discuss this topic with him.</u>
- 5. <u>ABCC Decisions</u>: The Town has received notice that the ABCC has upheld the suspensions for both the Narrows and Charlie's Place. The Board needs to hold a meeting with them to schedule their dates for suspension. Selectmen Potter stated that he does have both establishments coming before the board on December 9, 2008.
- 6. <u>AAA Traffic Safety Award:</u> The Wareham Police Department was awarded a Silver Award for their achievements in Traffic Safety.

- 7. <u>Wind Turbine at WPCF</u>: I met briefly with representatives of Atlantic Design Services to discuss the installation of a wind turbine at the WPCF. They would like to come before the Board to discuss this potential project. I suggest we schedule 45 minutes on the December 16 agenda for their presentation.
- 8. <u>Analog to Digital Broadcasting:</u> The Commonwealth's Department of Telecommunications and Cable has provided a notice that can be distributed relative to digital broadcasting. I will have copies made for distribution at the COA and in Town Hall.
- **9.** <u>**Transportation Enhancement Activities (TEA) Program:**</u> The Town has received notice from SRPEDD regarding Enhancement projects. I will be preparing the pre-application on this for submittal. Any guidance from the Board will be of assistance.
- 10. <u>Maple Springs Road.</u> Included in this report are pictures of Maple Springs Road, which were provided by Brock Tucy, as well as two (2) DVDs showing alleged violations and early truck traffic, which were copied from DVDs provided by Lisa Bindas.

Selectmen Potter would also like to have the Save our Library signs removed as they are considered political.
