SELECTMEN/SEWER COMMISSIONERS MEETING - 6-9-09 (CONT'D)

a. Hearing 7:15 p.m. – Show cause hearing on a Class II License issued to Russell Frayre d/b/a Auto Spirit II, 3070 Cranberry Highway, E. Wareham to determine if the license should be modified, suspended, revoked or cancelled under M.G.L. c. 140 s. 58-59

MOTION: Selectman Eckstrom moved to open the hearing. Selectman Donahue seconded.

VOTE: 5-0-0 (Unanimous)

Present before the board: Russell Frayre, Mary Tirrell, and Attorney Peter Winters

Attorney Winters was before the board asking if the board would consider transferring the Class II License back to the Tirrell's who are the owners of the property. Selectman Sauvageau advised Attorney Winters that that the board would not be able to discuss consideration at this hearing. Mr. Frayre stated that he had not read the hearing notice due to the fact that he wasn't home when the post office attempted twice to deliver the certified mail. Selectman Sauvageau read to Mr. Frayre the hearing notice. Mr. Frayre stated that he has run into financial problems and not able to obtain funds to reopen. Mr. Frayre said the floor plan financing is no longer available to him and all the vehicles went back to the floor plan company. Selectman Sauvageau stated that Ms. Tirrell could begin the application process for a new license.

7. TOWN ADMINISTRATOR'S REPORT

Selectmen Business

<u>Town Hall Trees</u>: The Wareham Garden Club has planted two Colorado blue spruce trees in front of the Town Hall that will grow to 50'-70' with a 25' spread. The foliage is silver blue-green and will look wonderful with holiday lights on them. AD Makepeace generously provided personnel to deliver and help Municipal Maintenance staff plant the trees, thus saving the expense of having to pay to have the trees delivered.

Webster Hall Hearing: The Hearing for Webster Hall was held Wednesday, June 3, 2009 at 11:30 a.m. at the ABCC office in Boston. The attorney for the Clermont Group was present but his client was not. We will await the ABCC's decision.

<u>License Renewals.</u> Enclosed is information concerning the renewal process for liquor and other licenses that the Board of Selectmen issues, including a fee schedule. The fees have not been changed since 2005.

Railroad Crossing/Elm Street. Survey work has begun for the replacement of the railroad crossing at Mill Pond Diner/Elm Street. It is expected that in the fall a new state-of-the-art concrete crossing will be installed at this location.

Town Hall Roof. The contractor will start replacing the Town Hall roof either the week of June 8, 2009 or June 15, 2009. They will utilize the parking lot behind Town Hall so we will lose some spaces during the project; no handicapped spaces will be lost, however.

SEWER BUSINESS

<u>Sewer Abatement Request—Account 736538, 18 Ryder Street, Map 7, Lot 181:</u> The Board is asked to approve abating this account for three months of 2nd half FY09 Sewer User Fee in the amount of \$145.98 for 1 EDU. The water was shut off November 4, 2007. The abatement covers the period November 4, 2008 thru January 31, 2009.

Mr. Sanguinet stated that he has spoken with the candidate for the Town Accountant position and was working on some requests that she had. Mr. Sanguinet has spoken with the two candidates for the Town Planner and was hoping that one of them could start part time between now and the end of the year.

Selectman Donahue thanked Chief Joyce for his 20 years of service to the Town of Wareham and wished him the best in his retirement.

Selectman Eckstrom provided the board with a copy of that final record of decision on the ADM mixed use development.
