#### 5. TOWN ADMINISTRATOR'S REPORT

<u>DA Response:</u> The Board received a letter late last week from the Office of the District Attorney relating to complaints made concerning Executive Session minutes and the Open Meeting Law. Mr. Sanguinet said he was pleased to see that the DA ruled, in most of the complaints, that the Board acted, or is acting, properly. In other complaints they indicated they had already investigated them and what their findings were. Mr. Sanguinet felt that it was important to announce good actions since only the bad things we are accused of doing are announced but the outcomes rarely are reported

Selectman Donahue asked that the board form a sub-committee to speak with the editorial board about the negative articles against the Town of Wareham

**MOTION:** Selectman Donahue moved to form a sub-committee consisting of 2 Selectmen to sit down with the editorial board at the Standard Times to address concerns. Selectman Eckstrom seconded.

Wastewater Contract Number 2: The Town received fourteen (14) bids for contract number 2. Bids ranged from \$4.7 to \$8.1 million. The final cost estimate was \$5.5 million. If the low bidder (P. Gioioso and Sons) checks out, the bid is \$800,000 below the estimate. P. Gioioso & Sons is the contractor for contract 1.

Heating Systems at the Police Station and Multi Service Center: Bids for both heating systems were favorable and both contractors should begin soon. Award Notices have been sent out and as soon as the documentation requested has been received a Notice to Proceed will be issued for the projects.

**Payroll Services Bid:** Mr. Sanguinet has awarded the bid for Payroll services to Harpers Payroll Services, which is the current provider. The next lowest bid was over \$10,000 higher.

**EMS Roof:** Mr. Sanguinet has contacted several references relating to the roof at the EMS building prior to awarding the bid, and will make the award as soon as the information is received.

<u>Health Insurance Trust Fund Audit:</u> Jim Powers and Biz have been working diligently on closing the audit on this very heated subject. As indicated by Ms. Zaleski and Mr. Sanguinet in early October, there are misclassifications of funds relating to how funds were transferred to the account. Both Mr. Powers and Ms Zaleski have indicated that the numbers are continually looking favorable to the Town. Estimated completion is first week in December.

#### 6. TOWN BUSINESS

a. Discussion with the Board of Health and Recycling Committee Re: Pay as you Throw (PAYT)

Present before the board: John Craig, Wastezero, Marilyn Field, Recycling Coordinator & Robert Ethier, Board of Health Agent.

Mr. Craig spoke about the Pay as you throw program and stated that the towns cost to purchase the bags would be approximately .27c each and then the residents would be able to purchase the bags at a cost between \$1.00 and \$2.00 depending on the size of the bag. The Board discussed that an RFP would have to go out for a hauler. Also discussed how recycling would increase with this program in place. Discussion ensued (as attached)
