# TOWN ADMINISTRATORS REPORT LEADERSHIP TEAM UPDATE

The Financial Management Information System "Train the Trainer" program that the Town Accountant has put into place will cover multiple offices. On Thursday, November 4, 2010, Marietta Maraccini of the Harbormaster's Office led a floor team effort of the Inspectional Services floor, including Sandi Silvia, Inspectional Services, and Suzanne Burke, Board of Health, thus taking the initiative for a top quality "Train the Trainer" program and cooperative effort between departments. This is an ongoing educational and cooperative process between departments.

## CEDA PUBLIC HEARING

On Monday, November 15, 2010, a public hearing was held at 6:30PM in the Town Hall Cafeteria to discuss the FY2011 grant application for the Massachusetts Community Development Block Grant (CDBG) Program. Included were a report on the progress of current grants and discussion of local community development and housing needs. Please see attached report prepared by Peter Sanborn, Community Opportunities Group. Present before the board: Peter Sanborn, Jacqui Hickey, and Sandy Besse Mr. Sanborn spoke about the Community Development Block Grant and said this is the second year that the Town has been able to apply for the grant. Mr. Sanborn stated that the town is fully assured of this grant but in order to receive it, the town has to meet certain performance, benchmarks for four of his previous grants. The Town has four active grants in which two are nearly complete and need to be completed and fully expended by December 10<sup>th</sup>.

Our Town planning includes written notification of roadwork and/or construction work in advance of the work crews arriving in the neighborhoods, a policy he implemented this summer. Further, Mr. Andrews urged Mr. Barrett to use this format for Water District use.
