8. TOWN ADMINISTRATOR'S REPORT

I. <u>LEADERSHIP TEAM</u>

A. FY2012 Budget (Operating & Capital Plan) and Budget message as submitted by the Town Administrator.

Mr. Andrews provided the board with FY2011 Budget update (as attached)

B. PERSONNEL UPDATE

Head of Reference Librarian: Mr. Andrews was pleased to introduce Laurie Cavanaugh, the new Head of Reference Librarian. Laurie is expected to begin work January 4, 2011.

Present before the board: Denise Medeiros & Laurie Cavanaugh
Ms. Cavanaugh introduced herself to the board and stated that she has been working at
the Brockton Public Library for the past 7 years.

- Financial Analyst/Researcher: Interviews were held Monday, December 13, 2010 for the three candidates who applied for the position. Interviews were conducted by: Selectman Brenda Eckstrom, Town Treasurer-Collector John Foster, and Town Accountant Biz Zaleski.
- <u>Assistant Harbormaster:</u> Interviews were held Wednesday,
 December 15, 2010 with Selectman Steve Holmes, Harbormaster

Garry Buckminster, and Director of Inspectional Services Myles Burke.

II. Due to Mr. Andrew's absence for Bereavement Leave, he was unable to make an appointment prior to preparing the informational packets for tonight's meeting, but he has spoken with Selectman Holmes concerning the Assistant Harbormaster interviews. Mr. Andrews hopes to make his recommendations to the Board for both these openings at the meeting.

C. FEMA REIMBURSEMENT

On Monday, December 6, 2010, Mr. Andrews received notification from FEMA that our efforts to document emergency spending related to Hurricane Earl have been received and either approved or in the process of being approved. He will keep the board posted.

D. FINANCIAL MANAGEMENT SUMMIT—STANDARD REPORTING

On Wednesday, November 10, 2010, Mr. Andrews convened a Financial Management Summit with Mrs. Brenda Eckstrom, BOS; Mr. Frank Heath, FinCom Report Specialist; Mr. Bob White, FinCom Liaison; Biz Zaleski and Judith Lauzon of the Town Accountant's Office; John Foster, Treasurer-Collector; Matt Underhill, Information Systems Manager; Guy Campinha, WPCF; Ana Miranda, School Department; Ted and Rob of VADAR Systems; and Mr. Jim Powers; Principle of Powers & Sullivan. The objective of this Summit was to discuss standardized reporting that can be developed to bring the highest level of effectiveness to our Financial Management Process. We had a robust discussion about using our resources in the most efficient manner and meeting our financial goals.

E. <u>STRATEGIC PLANNING—TEAM WAREHAM</u>

We have secured new interns from the Suffolk University Graduate School of Public Administration. Mr. Andrews met with Kevin Clayton, Derek Sullivan, Nefrediazha Barbel, Greg Rounseville, Michaela Miteva, and Kathleen Moore. Mr. Andrews wanted to keep you posted on our continuous efforts to plan strategically, especially in our FY2012 Budget building process. On Wednesday, November 10, 2010, Mr. Andrews held a Strategic Planning Workshop with our Leadership Team, along with Team Wareham. Mr. Andrews has formed Team Wareham to work with our Leadership Team on developing a Strategic Plan for their respective Department. Mr. Andrews has asked each member of the Leadership Team to use the Strategic Planning Process to "strategically think" about opportunities, both operational and capital costs. Mr. Andrews will take these recommendations as he develops his FY2012 Spending Plan.

The Interns provided the board with a presentation about the Strategic Planning Survey and the SWOT analysis.

F. INTERNET, HARASSMENT, AND DRUG USE POLICIES

For the Board's information, all employees were given updated Town Counsel-approved policies for the following: Internet, Harassment, and Drug Use. The new forms were presented to the Leadership Team for their use for all employees in their Departments, both full- and part-time. These forms will be digitized and kept on file in our Personnel Department.

H. ME FY2008 GRANT #00038—REDUCTION OF FUNDS

For the Board's information, there will be no further expenditures charged to this grant. The grant has been reduced by \$18,660.15 to reflect the balance of funds that have been unexpended at the close of the grant.

J. ONSET BAY ASSOCIATION'S CHRISTMAS IN THE PARKS

K. JORDAN HOSPITAL MEETING WITH TOWN LEADERS

On Wednesday, December 1, 2010, Mr. Andrews attended the Health Care Forum along with Selectmen Walter B. Cruz Sr. and Steve Holmes. Mr. Rick Holden, President of Jordan Hospital, led a very intense update on Health Care Reform in America. Discussion centered upon Health Care Reform and partnerships with communities. This was an introductory meeting with additional forums to follow.

Chairman Donahue stated the Chief's recommended putting this off until he can come before the board with a recommendation regarding the tow list. Chairman Donahue advised Mr. Brogle that they would ask him to return after the first of the year once they get the information back from Chief Stanley.

b. Discussion of Shooters Restaurant Liquor License Chairman Donahue stated that Shooters has been informed that they need to submit their application for renewal.

Chairman Donahue stated that the renewals for the Common Victualler's licenses would be extended until January 3rd at 4:00 p.m. due to the holiday.

c. Any other Town business

Selectman Holmes spoke about an accident on Swifts Beach Road, in which a vehicle drove thru a home and read a letter from Myles Burke in response to a question he has asked.

Selectman Holmes spoke about a new policy for Class II licenses and asked if he can write up a new policy for the next meeting.

10. SEWER BUSINESS

Chairman Donahue recused herself for this portion of the meeting and asked that Selectman Cruz serve as Chairman.

i. Approval of ARRA Funding Split

MOTION: Selectman Eckstrom moved to split the funding 50/50. Selectman Winslow seconded.

VOTE: 4-0-0 (unanimous)

ii. Approval of Interest Rate to be applied

MOTION: Selectman Winslow moved to set the interest rate at 2%. Selectman Holmes seconded for discussion. Selectman Holmes stated that the town should have a cushion and not set the interest at 2%. Discussion ensued over the rate. Selectman Winslow withdrew her motion.

MOTION: Selectman Eckstrom moved to set the interest rate at 2.5%. Selectman Holmes seconded.

VOTE: 3-1-0 (Selectman Winslow opposed)

iii. Approval of Final Betterment Number

At this time Selectman Donahue returned

b. Extension of Time – Contract #1
This would be an extension of time at no cost.

Selectman Winslow moved to accept the extension of time under the change order for 140 days, which brings the contract completion date December 24, 2010 with no additional costs. Selectman Cruz seconded.

VOTE:

4-0-0 (unanimous)

Note: Selectman Eckstrom was not in the room at the time this vote was taken.

Selectman Winslow stated that the warrant that was originally to start on December 8th should start one year from December 24, 2010 since the board just voted on the extension of time.

Acceptance of Contract #1 Substantial Completion

Selectman Winslow moved accept the substantial completion with the change to the warrant date being the official completion date of December 24, 2010. Selectman Holmes seconded for discussion. Mr. Sanguinet stated that legally the warranty begins when the substantial completion is met which was December 8, 2010. Selectman Holmes seconded.
