7. TOWN ADMINISTRATOR'S REPORT LEADERSHIP TEAM UPDATE:

Present before the board: Chief Stanley
Chief Stanley thanked Lt. Wallace for his 35 years of service and wished him well on
his retirement. Chief Stanley was grateful for the assistance that he has provided. He
was before the board to promote two officers Sergeant. John Walcek to Lieutenant
and Officer Peter Flannery to Sergeant. Mary Ann Silva had sworn both in.

John Foster was before the Board to give an update on the Tax Title. Mr. Foster said that currently there are 10 properties scheduled to go into land court and they all have bank assistance and he is hoping to collect those fees from the banks. He said that the next grouping is 49 properties designated for legal action. There are 17 properties that are being held for further research. Mr. Foster went over the land of low value properties and stated they did try in the spring to auction off these properties however they didn't get any bidders.

Mr. Andrews have asked Garry Buckminster, Harbormaster/Shellfish Constable, to come before the Board to discuss the Commercial Oyster, Soft Shell Clam Fisheries, Agawam Beach Shellfish Management Area #1, and Broad Cove and East River Shellfish Management Area #2 as per the attached reports. The Commercial Oyster regulations are in effect December 1, 2010 through March 31, 2011, Soft Shell Clam Regulations November 1, 2010 through April 30, 2011, Agawam Beach Shellfish Management Area #1, and Broad Cove and East River Shellfish Management Area #2 effective November 1, 2010.

Recommended action: Motion for the Board to approve the Commercial Oyster regulations effective December 1, 2010 to March 31, 2011, the Commercial Soft Shell Clam regulations effective November 1, 2010 to April 30, 2011, Agawam Beach Shellfish Management Area #1, and Broad Cove and East River Shellfish Management Area #2 effective November 1, 2010 in accordance with the provisions of MGL Chapter 130, Section 52 and the attached regulations.

Article #80 - Clean Water Committee, Present before the board: Ed Pacewicz & David Begley

Mr. Pacewicz said this article would hold standards with nitrogen net zero with new construction that takes place that's above 3300 gallons or 10 homes would require being net zero. Mr. Pacewicz also spoke about nitrogen.

MOTION: Selectman Holmes moved favorable action on article #80. Selectman Eckstrom seconded.

VOTE: 4-0-1 (Selectman Cruz abstained)

Chairman Donahue stated that the Westfield Study Committee would be before the board at the next meeting.

Article #85 - COA Board of Directors

Present before the board: Rich Boucher and Marcia Griswold
Mr. Boucher was looking to reduce the number of members from 11 to 9 members
and to add 2 associate members as recommend by the Massachusetts office of Elder
affairs.

MOTION: Selectman Holmes moved favorable action on article #85. Selectman Eckstrom seconded.

VOTE: 2-3-0 (Selectman Holmes, Cruz & Winslow opposed)

Article #87 - Community Events Committee Present before the board: Susan Ricci

The board previously voted in favor of this article 5-0-0. Ms. Ricci was before the board giving a report and stated that the CPC will be accepting applications until

Article #90 - Accept layout of Rock Marsh Road.

Present before the board: Phil McClintock & Richard Callinan Mr. McClintock said that the development was completed in 2008. Mr. Callinan said the problem started back in February 2005 when the Planning Board didn't file it's decision with the Town Clerk in time and as a result the application filed suit in Superior Court seeking construction approval. Mr. McClintock spoke about some discrepancies in the Planning Board meeting minutes of January 9, 2006. Mr. Callinan stated that the board would have to hold a public discussion of the laying out of the street as a public way and according to the policy the board would need to vote it's intention to do so and refer the petition to the Planning Board for it's recommendation and the Planning Board has scheduled a discussion of Rock Marsh Road next Monday.

MOTION: Selectman Eckstrom moved that the Board forward the intent of the lay out of the road to the Planning Board. Selectman Winslow seconded.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Holmes moved favorable action on article #90. Selectman Winslow seconded.

VOTE: 5-0-0 (Unanimous)

Article #91 – Article regarding Wind Turbines

Present before the board: Lynne Burroughs

Ms. Burroughs stated that if eight wind turbines were to be erected in Wareham and very little information is known about environmental and other impacts associated with wind turbines. Ms. Burroughs stated that our current bylaws put little restriction on the turbines. She feels that it's in the towns best interest to review any plans associated with the erection of the wind turbines in the town and they should be afforded the opportunity on weather or not they want them as they will permanently Wareham's beautiful landscape.

MOTION: Selectman Holmes moved favorable action on article #91. Selectman Eckstrom Holmes seconded.

VOTE: 3-2-0 (Selectman Winslow & Cruz opposed)

Ms. Silva was before the board to discuss bylaw changes.

Present before the board: Mary Ann Silva

First Article discussed was Relative to Animal Control Article #76. Ms. Silva said the article was about changing or raising the fees. She stated that the kennel fees have not been raised since 2002 and they have risen the licensing of dogs twice. She stated that it's a matter of a \$10 increase. She stated that another increase would be to increase the Business certificate to \$50, which is good for four years. She also stated they have to amend the business certificate which requires to retype and add which takes a few minutes which would be increased to \$10. Ms. Silva would be increasing the charge for replacing dog licenses since they have to make them themselves. They would like to increase the charge to amend a birth certificate from \$25 to \$30 since it involves such work to amend a birth certificate as well as to amend a death or marriage certificate. She said currently the oath of office as commissioners current fee is \$8 and would like to raise it \$10. Also vital records will also be increasing and effective January 1st the Clerk's office will have access to all birth records in Massachusetts and they will be able to print out a birth certificate therefore the charge will increase from \$5 to \$10.

MOTION: Selectman Eckstrom moved favorable action on article #76. Selectman Winslow seconded.

4-0-0 (Selectman Cruz recused himself)

Article #77 - Relative to Animal Control

Ms. Silva stated that anyone who has a small kennel or a hobby kennel don't do boarding or grooming of dogs. She stated that they did have an issue where this did happen and she had several people come to her asking if they could make it more restrictive. Ms. Silva stated that she did meet with Attorney Rich Bowen last Friday asking if this was lawful and he stated that she could make it more restrictive but couldn't make it less restrictive. Selectman Winslow stated it was her understanding that when the Director of Inspectional Services investigated that matter he gave written opinion on the hobby kennel licenses on what was allowed and what wasn't allowed and believes that he consulted with Kopelman & Paige at the time. Ms. Silva stated that she wasn't sure and didn't get a copy and she sat with Attorney Bowen and he stated that this was allowed. Chairman Donahue stated that this clarifies the difference between a small kennel, hobby kennel and a commercial kennel.

MOTION: Selectman Winslow moved no action (no 2nd motion failed) Selectman Holmes moved favorable action on article #77. Selectman Eckstrom seconded.

Article #78 - Animal Control - Kennel Licenses

abstained)

Changes in paragraph seven to be made that the owner shall pay full price for the new kennel license most recently approved and by adding paragraph eleven: Any and all license holders in the business of selling or boarding dogs for profit, must register with the Town of Wareham by acquiring a Business Certificate from the office of the Town Clerk.

MOTION: Selectman Holmes moved favorable action on article #78. Selectman Eckstrom seconded.

VOTE: 4-0-1 (Selectman Cruz abstained)

Article #79 - Penalties for failure or tardiness to license kennels Ms. Silva said this encourages them to come in and license their dogs.

MOTION: Selectman Holmes moved favorable action on article #79. Selectman Winslow seconded.

VOTE: 4-0-1 (Selectman Cruz abstained)

The board took a three-minute recess.

Chairman Donahue continued with Charter Changes
Present before the board: Alan Slavin. David Begley & Mary Ann Silva
Article #75 Mr. Slavin said the first change was to the Community Preservation
Committee by changing membership from Recreation commission to the Open Space
Committee.

MOTION: Selectman Eckstrom moved favorable action on article #75. Selectman Winslow seconded.

VOTE: 5-0-0 (Unanimous)

Article #67 - Amend Town Bylaws

Mr. Slavin said the change would change the start date to the 1st Tuesday in May and then the 4th Monday of May would be the action Town Meeting.

MOTION: Selectman Eckstrom moved favorable action on article #67. Selectman Holmes seconded.

VOTE: 4-1-0 (Selectman Cruz opposed)

Article #68 – Amend Town Bylaws, Duty of the Finance Committee Said recommendations shall note the voting of the Finance Committee, i.e., affirmative and the negative vote with a pro and con opinion provided.

MOTION: Selectman Eckstrom moved favorable action on article #68. Selectman Holmes seconded.

VOTE: 3-2-0 (Selectman Cruz & Winslow opposed)

Article #69 – Amend Town Bylaws – Selectmen as Town Employee No person elected Selectmen may be an active employee of the Town during his term of office as Selectman. Upon qualification of office, the employee shall take a leave of absence or resign from said position with the Town of Wareham.

MOTION: Selectman Eckstrom moved favorable action on article #69. Selectman Holmes seconded.

VOTE: 3-2-0 (Selectman Holmes & Winslow opposed)

Article #70 – Amend Town Bylaws – Selectman serving as liaison. Clarification that members of the Board of Selectmen may act as a Liaison to assigned Boards and Committees as a non-voting member, except by Charter provisions.

MOTION: Selectman Winslow moved favorable action on article #70. Selectman Eckstrom seconded.

VOTE: 4-0-1 (Selectman Eckstrom abstained)

Article #71 – Amend Town Bylaws – Appointment of Finance Committee Mr. Slavin stated that if Article 40 passes then this could move forward.

MOTION: Selectman Eckstrom moved favorable action. Selectman Holmes seconded.

VOTE: 1-1-3 (Selectman Cruz opposed, Selectman Winslow, Eckstrom & Donahue abstained)

Article #72 Amend Town Bylaws - To take articles at Town meeting by lottery This would take the budget articles first then and then in order as drawn by the Town Clerk by lottery.

MOTION: Selectman Holmes moved favorable action on article #72. Selectman Eckstrom seconded.

VOTE: 1-2-2 (Selectman Winslow and Cruz opposed, Donahue & Eckstrom abstained)

Article #73 Amend Town Bylaws – The Rules that Govern Town Meeting This would use on the Robert's Rules of Order during Town Meeting MOTION: Selectman Holmes moved favorable action on article #73. Selectman Eckstrom seconded.

VOTE: 3-2-0 (Selectman Winslow & Cruz opposed)

Article #74 – Amend Town Bylaws – Setting Rules for petitioned articles Proponents or sponsors of an article shall be responsible to present the article and motion at town meeting.

MOTION: Selectman Holmes moved favorable action on article #74. Selectman Winslow seconded.

VOTE: 4-1-0 (Selectman Cruz opposed)

Article #51- Charter Change to limit the pay of Town Administrator upon their removal.

This article seeks to limit the compensation of the Town Administrator upon their removal from office.

MOTION: Selectman Winslow moved favorable action on article #51. Selectman Eckstrom seconded.

VOTE: 0-5-0 (unanimous)

Article #52 Charter Change to require board of Selectmen Approval. He shall fix the compensation of all town officers and employees appointed by the Town Administrator within the limits established by appropriation, the provisions of town by-laws, and subject to the approval of the Board of Selectmen.

MOTION: Selectman Winslow moved favorable action on article #52. Selectman Eckstrom seconded.

VOTE: 4-1-0 (Selectman Cruz opposed)

MOTION: Selectman Winslow moved to adjourn the meeting at 10:00 pm. Selectman Eckstrom seconded.

VOTE: 4-0-1 (Selectman Eckstrom abstained)

c. Vote and approve the Wareham Police Department Policies & procedures

Present before the board: Chief Stanley
Chief Stanley said that putting the 46 new policies in place in now places them up for certification. In a couple of weeks there will be a mock assessment of the police

department and in November they will access the department and see where they stand and he is confident that they will become one of only 40 Police Department in Massachusetts that are certified. Be given certification in January and accessed in April for accreditation.

Selectman Winslow moved to accept the Wareham Police Department MOTION: Policy 41.2.1 Responding Procedures, Policy Chapter 46 critical incidents, special operations, Policy Chapter 42.2.7 confidential informants, policy accreditation maintenance, policy property and evidence control, policy holding facility, policy inspections inventory audits, policy forcible stopping roadblocks, policy role call firearms inspection, policy central records, policy obey lawful orders chain of command, policy harassment prevention orders, policy restraint chair policy, policy organizational chart, policy uniforms and equipments. Selectman Eckstrom seconded.
