### 4. CITIZENS PARTICIPATION

Present before the board: Tiny Lopes

7. **TOWN ADMINISTRATOR'S REPORT**

**LEGISLATIVE UPDATES**

S.2520, the so-called Wareham Jobs Bill, An Act Authorizing the Town of Wareham to grant 8 (eight) additional licenses for the sale of alcoholic beverages is on the Governor's desk. On Tuesday, July 20, 2010, this Landmark Legislation was given final approval in both the Massachusetts House of Representatives and State Senate. The enactment of S.2520 marks a milestone in Wareham's history. The eight (8) additional liquor licenses will provide an opportunity for local restaurants to expand, create jobs and bring sustainable private investment in the future. Mr. Andrews wanted to applaud our Legislative Delegation and their staff for all their hard work. Senator Marc Pacheco and Representative Susan Williams Gifford are to be commended. The legislation is on Governor Patrick's desk and he has sent a letter urging the Governor to sign S.2520 as soon as possible. Mr. Andrews will keep you posted on this important legislative matter.

**LEGISLATIVE WORKSHOP:** Mr. Andrews has coordinated with Chairwoman Donahue a legislative implementation workshop for S.2520 to be helpful for the restaurants in our economic target zones. This workshop is scheduled for Friday, August 6, 2010, at 2:00 p.m. at Wareham Town Hall, Conference Room B. You are invited to attend.

**LT. GOVERNOR TIM MURRAY:** Friday, July 23, 2010, at 11:00 a.m., Lt. Governor Tim Murray was here for the groundbreaking ceremony for the commencement of the Besse Park Bulkhead Replacement Program. This capital improvement program was supplemented by a \$575,000 grant from the Commonwealth of Massachusetts. Light refreshments were served to celebrate this important event.

**FOX 25 ZIP TRIP:** On Friday, July 16, 2010, we hosted the Fox 25 Zip Trip on Onset Bay pier at 6:00AM. This was a marvelous opportunity to showcase Onset Village as a prime destination point on the South Coast. Mr. Andrews was interviewed and stressed Wareham's strengths as: "Same Sun, Same Sand, Same Water, But, No Bridges!" Additionally, we highlighted the Safe Summer 2010 group efforts of our entire team--Jackie Lindsey, Wareham Village Association; Mary Lou Payton, Onset Bay Association; Police Chief Rick Stanley; EMS Director David Evans; Health Agent Robert Ethier; Director of Inspectional Services Myles Burke; Council on Aging Director Marcia Griswold; and Acting Harbormaster/Shellfish Warden, Garry Buckminster, and focused on our economic advantages—New lifeguard program, great

restaurants, and business base that make us an ideal destination point for the region. Well over 1,000 people participated in this event.

### **PERSONNEL UPDATE:**

**PLANNER:** Mr. Andrews introduced Mr. John Charbonneau, our new Planner, who has worked in Framingham and at SRPEDD. Mr. Charbonneau has worked with Chapter 40A as well as with GIS. He also has experience preparing grant applications. He has also had experience with preparation of master plans as well as open space and recreation plans. He was the unanimous choice of our Committee, including from Rochester: Rich LaCamera, Town Administrator, Arnie Johnson, Chairman of the Planning Board, Bob Cummings and Dan McGaffey, Planning Board Members, and from Wareham: Brenda Eckstrom, Selectwoman, Myles Burke, Director of Inspectional Services, Brenda Sampson-Urolatis, Planning Department Assistant, and myself. Our joint venture with Rochester is moving forward.

Present before the board: John Charbonneau

Mr. Charbonneau went over his education and experience background.

**CHIEF STANLEY:** The Chief and Mr. Andrews have met to continue discussion and we are progressing on a contract. He has been consulting with the State Department of Personnel Administration. Mr. Andrews will keep you posted.

**DIRECTOR OF ASSESSMENT:** We have received the resignation of Rich Gonsalves, Director of Assessment, and effective July 30, 2010. Mr. Andrews has appointed Sheila Scaduto as Acting Director of Assessment effective August 2, 2010.

**EMS:** Russell Widner, an Emergency Medical Technician-Paramedic with Wareham's EMS Department, has resigned effective August 3, 2010.

**GLEN COVE AND ONSET BEACH MOBILE HOME PARK STORMWATER PROJECT:** On Friday, July 16, 2010 this \$94,000 project was completed. The engineering firm of Hancock Associates will now create the final easement and as-built plans for this Capital Improvement Program.

### **LEADERSHIP TEAM FINANCIAL MANAGEMENT:**

**Action Log:** Mr. Andrews has created a comprehensive Financial Management Log for all meetings beginning July 21, 2010. My intention is to resolve in a systematic manner all of these concerns and recommendations.

**FISCAL WORKSHOP ON FY2009 AUDIT:** As planned, we have scheduled a joint meeting with our Finance Committee on Wednesday, July 28, 2010, at 6:30PM in the Board of Selectmen meeting room. This is a workshop that will include Mr. James Powers, Partner and Chief Auditor on our FY2009 Independent Audit Report. He will provide a financial update and cover the elements of the FY2009 audit report.

**SIGNAGE FOR SOUTH WAREHAM UNDERPASS:** We have purchased additional signs (stressing the height and clearance) including 11' 6" with one on Tobey Road as a new sign, to warn drivers on Tobey Road and Fearing Hill. Also, we are replacing two existing signs and adding signs to the fascia of this bridge support structures. He will keep you informed.

**THURSDAY, AUGUST 5, 2010--WAREHAM SKIN CANCER SCREENING DAY, 10:00AM-3:00PM ON ONSET BEACH.** This is the result of member Brenda Eckstrom and Mr. Andrews will have lunch with the Regional Human Services Provider Coordinating group. Our Lifeguards, along with Myles Burke and Bob Ethier, will coordinate the day's activities. We will provide free sunscreen, beach ball giveaways, raffles, and the screening van will be on the premises. Our Board is encouraged to attend this important health awareness program.

8. **TOWN BUSINESS**

a. Vote on State Election Warrant

**MOTION:** Selectman Cruz move the board to approve and read the state elections warrant (as attached) Selectman Winslow seconded.

**VOTE: 5-0-0 (unanimous)**

b. Vote on accepting a new law amending MGL c. 138, §33B which authorizes local liquor licensing authorities (LLA) to permit MGL c. 138 §12 licensees to sell alcoholic beverages at 10:00 a.m. on Sunday's

Chairman Donahue stated that she has only heard from one of the establishments asking for the board to vote in favor. The Board will wait on approving this until they hear from other establishments.

c. Discussion/Establishment of Town Meeting Dates & Notice of Intent.

Selectman Eckstrom stated the date should be changed for the last day to submit petition articles from August 27, 2010 to September 3, 2010.

**MOTION:** Selectman Cruz moved to approve the dates for process for calling a town meeting (as attached) with an amendment on the Friday, August 27, 2010 to change to Friday, September 3, 2010. Selectman Eckstrom seconded.

**VOTE: 5-0-0 (unanimous)**

**MOTION:** Selectman Winslow moved to go beyond the hour of 10:00 pm. Selectman Eckstrom seconded.

d. Discussion of appointments to boards, committee or commission.

Selectman Cruz moved The Wareham Board of Selectmen certainly value the significant contribution of all volunteers and encourage further participation by all citizens of the Town of Wareham for all Board, Committees, and Commissions. The Board of Selectmen, when making such appointments should take into account the number of Boards, Committees and Commission from which appointees are made. Said appointment are restricted to no more than two (2) per individual per year and/or for the term of appointment, but are limited to this amount as maximum total. Selectman Holmes seconded for discussion. Selectman Holmes said he supports limiting the number of committees and has never questioned anyone's integrity. He does appreciate people volunteering for the town. He said he would like to see the number at three (3) committees rather than two (2). Selectman Winslow stated this isn't personal and it's not directed to anyone. She said that she received a call from someone who suggested having a sub-committee to look into this problem. Identify issues and come back to the board with a recommendation. Selectman Winslow also agreed with Mr. Holmes that the number of committees should be three (3). Selectman Eckstrom stated that someone at the beginning of the meeting came before the board and asked for an apology because when his integrity was questioned. She said that she cannot apologize on behalf of the board but personally she said she was sorry she didn't speak up. Selectman Eckstrom feels that there should not be placing any limits on boards. Chairman Donahue said that she feels the time and place to bring this up is when the person appears before the board when applying for a board or committee. She said that she is not in favor of this policy and said that if the board does agree to move forward they should agree to three (3) boards or committees. Selectman Holmes withdrew his motion to second. Selectman Cruz withdrew his motion.

**MOTION:** Selectman Holmes moved that the Board appoint a sub-committee of the Board of Selectmen of two members to review the current list of advisory councils and boards, to review the process of appointment to filling out the applicant to the appointment, to review the relevancy of the current boards to suggest new boards that may be relevant at this time and to also review the process of local interviews and local board recommendations. The report would come back to the board by August 17, 2010. Selectman Winslow seconded for discussion. Chairman Donahue asked for Selectman Holmes to clarify what he meant by we should review the process of other boards. He said if someone comes in today and they send them to the local board and the board sends a recommendation to the Board of Selectmen. He thinks that process should be reviewed since the Selectmen are the appointing authority. Selectman Eckstrom stated that was always the procedure as a courtesy to the other boards. Chairman Donahue feels that they should get the input and recommendations from other boards and commissions. Selectman Winslow withdrew her motion to second.

**MOTION:** Selectman Holmes moved that the board create a sub-committee as a whole to review the entire board and appointment process, reviewing the list of current boards and the process of appointments, the scheduling of the advisory that reports back to the Board of Selectmen. Selectman Eckstrom seconded.

- e. Any town business

Selectman Winslow said she did get to ride along with the officers and wanted to thank Chief Stanley, Lt. Walsh, and Sgt. Walcek and Sgt. Correia along with Officer Pillsbury for allowing her to do so. She commended the police force and said that they do work very hard.

Selectman Winslow spoke about an email that was between the Board of Selectmen, Mr. Andrews and Mark Gifford. She said the email had to do with a story that appeared in a local newspaper regarding our Municipal Maintenance Department. Selectman Winslow said that she wanted to clarify that the original email sent to the Chairman of the Board suggested based on the news story that it would be nice to invite the employees of the municipal maintenance involved and thank them publicly for their efforts in finding an engagement ring. She said that there was no mention of any private citizen in this email. She stated that today it was brought to her attention that on another local website about a story and she wanted to make it very clear this issue of honoring our employees of this community who are working hard, have not had a raise in years and are working short staffed and who took furlough days last year, she said no one has the right to diminish the honor that she or any other board member wants to bestow on them. She stated that it was an insult to the municipal maintenance employees and it was unfair to them and they are owed an apology.

Selectman Holmes wanted to remind the board and committee Chairs that they need to post an agenda along with posting the meeting.

**9. SEWER BUSINESS**

- a. Discussion of Sewer Betterment options.

Chairman Donahue recused herself from this discussion and turned the Chairmanship over to Selectman Cruz.

Present before the board: Mr. Sanguinet, Mark Gifford and Mike Guidice

Mr. Sanguinet said that contracts 1 & 2 have been bid and contract 3 has not been bided on yet. He said that they wouldn't know the final numbers until the project has been completed. The short-term interest amount will be applied as well as administrative fees. The total estimated cost of the projects before any reductions are for contract #1 is \$6,683,079 and for contract # 2 \$5,571,270 and in contract #1 there are 438 properties being bettered and in contract #2 there are 257 properties being bettered. The estimated cost for contract #1 is \$15,337 and contract #2 \$22,091. Mr. Sanguinet stated that the board needed to decide on how to use the stimulus funds. The board can apply the stimulus based on the number of properties in each project, if so contract #1 would receive 63% of the stimulus reducing their betterment to \$14,893 where contract #2 would receive 37% which would reduce the estimated betterment \$22,848. Selectman Winslow asked if it was an option to split the stimulus 50/50 between the two contracts in which Mr. Sanguinet replied it was an option. Selectman Holmes asked when the

money was awarded was it a lump sum or was it awarded for each project. Mr. Sanguinet stated that the state applied it to the overall loan for contract #1 and #2. Selectman Cruz stated that they will be having a meeting on Saturday with the residents and if they have any questions they should attend.

Selectman Winslow seconded.



October 26, 2010 General Business

TUESDAY, July 27, 2010	Board of Selectmen should establish all dates for completion of a Warrant for the Fall Town Meeting.
FRIDAY, August 20, 2010	Last day to post in at least one public place in each precinct, Notice of Intention of Board of Selectmen to call the Fall Town Meeting for October 25, 2010. (By-Law Div. I, Art. I, Sec. 3.) - <b>10 days notice before Warrant closes.</b>
FRIDAY, August 27, 2010	Last day to submit petitions (articles) to be inserted in the Warrant. (WHRC Section 2-4 (c) - <b>45 days or more before Town Meeting convenes.</b>
TUESDAY, September 14, 2010	Board of Selectmen should officially close the Warrant.
