6. HEARING - FY11 RESIDENTIAL FACTOR

MOTION: Selectman Eckstrom moved to open the hearing. Selectman Winslow seconded.

VOTE: 4-0-0 (Unanimous)

Present before the board: Sheila Scaduto & Steve Curry
Ms. Scaduo was before the board to set the FY11 Residential Factor.
She stated that the FY11 levy increased by 3.6% and the values decreased by 6.5%.
The Residential values decreased by 6.5% and Commercial and Industrial values decreased approximately 3%. The FY11 new growth is \$302,140 of that \$170,160 is from the residential class, \$37,054 is from the Commercial and Industrial classes.
\$94,926 is from personal property. Ms. Scaduto went over the Scenario worksheet with the board

Chairman Donahue asked if anyone in the audience wanted to speak for or against the tax classification rate.
