Mr. Andrews spoke about the Health Care holiday premium – Selectman Winslow stated that she does not believe that taking money from the heath care trust fund to fund a one time gap will only leave us in the same place next year is a wise idea. She said if there is excess in the trust fund it tells her that we have been overpaying the trust fund and perhaps changing and lower the contribution rate for both the town and the employee over the long hall would be the better way to go. Selectman Holmes asked the school dept if they are using \$971,000 to fund school operations. Operations are an annual expense what happens next year? He said the answer was that next year the town is going to chip in \$500,000. Selectman Holmes did research on premium holidays and said that it's happened in other towns in Massachusetts over the past years without very good results. He also checked with the DOR and they said it was legal, unwise and not recommended therefore; he will not be supporting the memorandum. Selectman Schneider said that for the most part he does agree with both his colleagues. He said that the fund should be used for a one-time operation expenses and also said that the school would still have a 2.4 million school bus problem next year. Selectman Schneider stated that he wouldn't support it as well. Selectman Begley asked if the MOU was done at a school committee meeting? Chairman Cruz stated that it was a meeting with Dr. Rabinovich, himself and Mr. Andrews. Selectman Begley feels that the school department needs to have their budget looked at the same way the Town's budget is looked at with a great deal of scrutiny. Chairman Cruz stated that the money has to come from somewhere. Mr. Andrews said by having the independent auditors looking at this account he could say that this is a healthy fund balance and they have protected themselves with stop loss insurance.

MOTION: Selectman Holmes moved that the Board of Selectmen reject the Memorandum of Understanding health care premium holiday. Selectman Winslow seconded for discussion. Selectman Winslow said that she couldn't support this MOU as there has to be a better way. Selectman Begley said that she couldn't support this unless she knew that it was only going to be a one-time event. Selectman Schneider said from his point he would like to send a message to town meeting that it's legally acceptable but he's something that he is not prepared to do.
