# 4. SURPLUS EQUIPMENT

Chief Stanley was before the board asking for them to declare equipment as surplus property.

Present before the board: Mr. Cross, Bayside Agricultural, Mr. Robertson Mr. Robertson said that Bayside Agricultural will offer at no charge to the town should they select a piece of land that will align Seth Tobey Road and Tow Road on Rte 28.

Mr. Campinha was going to talk about setting the betterments for contract #2 (Selectman Slavin has recused himself at this time). Mr. Camphina said he went over the punch list with Mr. Guidice. Selectman Winslow stated that in reviewing previous meeting minutes the board voted on a 50/50 split on the arra funds. Mr. Deshaines have provided Mr. Campinha with all his numbers minus the appraisal fees. The board asked that they get the cost of the betterment to them soon.

#### 9. TOWN BUSINESS

a. Stormwater Management Committee

Present before the board: Mark Gifford

Selectman Slavin stated that since the Planning Board and Conservation Commission has this as part of their working plan the Committee is no longer needed. Mr. Gifford stated that part of their job is to outreach to the community and they do have flyers available in the Harbormaster and Conservation Commission offices. He said they keep track of all the catch basins they clean as well as having all the streets swept at least one a year. Some discussion ensued whether to sunset the committee or not. **MOTION**: Selectman Slavin moved to sunset the committee. Selectman Winslow seconded.

**VOTE:** 3-1-0 (Selectman Begley opposed)

b. Any other town business not reasonably anticipated 48 hours prior to the posting of this meeting

Selectman Holmes stated that he spoke with Attorney Bowen about having board members sitting in on the Steelworkers union negotiations since Mr. Foster and Mr. Sullivan cannot be part of it due to them both being members of that union. Chairman Holmes stated that Attorney Bowen suggested that 1 or 2 members of the Board of Selectmen attend these meetings, get the information and report back to the board. He stated that they cannot and should not agree to anything. Selectman Winslow stated that a mediation session isn't a negotiation session.

**MOTION**: Selectman Winslow moved that two Selectmen attend the mediation sessions between the Town of Wareham and the Steelworkers Unit. Selectman Begley seconded for discussion and stated that due to Selectman Winslow's experience she urged the board to have Selectman Winslow as one of the Selectmen and stated that she would like to be the other member.

VOTE: 4-0-0 (Unanimous)

**MOTION:** Selectman Belgey moved that the two members that would attend these sessions would be Selectman Winslow and Selectman Begley. Selectman Slavin seconded for discussion. He asked if it was appropriate to hold off on the second member until Mr. Teitelbaum is a member. Chairman Holmes stated that since the meeting is this week they would need to get the names to Mr. Garrett. Chairman

Holmes asked that Selectman Winslow be very careful due to her knowledge with negotiations.
